## **JUDGEMENT**

# (Delivered on this 16<sup>th</sup> day of April, 2014)

2. Shri Raghunath Balkrishna Dagwar presented this application on 28-02-2014 feeling aggrieved that the order passed by IGRC Wardha under no.SE/Wardha /Tech/IGRC/3241 dated 16-06-2012.

The applicant applied to the MSEDCL for new electricity connection in January 1986. The MSEDCL did not release the connection. In the meantime the applicant, due to some family problems, decided not to take the connection. So he demanded the amount deposited by him towards the new connection. The applicant requested that directions may be issued to the MSEDCL to refund the amount with interest.

In reply the MSEDCL stated that if the applicant produce the receipt of the amount deposited by him the amount will be refunded to him. The amount will be refunded as per the existing orders of the superior office.

We have perused the record. We have heard the arguments advanced by both the parties on 15-04-2014.

It is admitted fact that the applicant deposited Rs.1860/- for getting the new connection. Now he is not interested in getting the connection. The respondent also accepted to refund the amount. So we direct the respondent to refund the amount as per the existing tariff orders. The application is hereby disposed of in terms of the aforesaid directions.
