**JUDGEMENT**

**(Delivered on this 25<sup>th</sup> day of February, 2015)**

2. Shri Gurudeo Nago Gaikwad, r/o.Kanchangaon, Po.Arvi(small) Tq.Hinganghat Dist.Wardha submitted an application for single phase domestic connection. The application was submitted on 16-09-2014 He approached IGRC with a grievance that the respondent has not given him a demand note. Now he admitted that he got the demand note. He deposited the required amount on 15-11-2014. He submitted the test report on 21-11-2014. He submitted the grievance application before this Forum on 15-01-2015. Now his prayer is that the respondent may be directed to release the connection immediately.

The case was fixed for personal hearing on 23-02-2015. Both the parties were

heard.

Shri Vaidya, Executive Engineer, Hinganghat replied that the applicant came here with prayer for release of connection. The applicant did not submit this prayer before IGRC. So his application dated 15-01-2015 is in contravention of the provisions of Regulation 6.2 and 6.3 of the MERC (CGRF & EO) Regulations 2006. He submitted the test report on 21-11-2014. To release the connection the augmentation of existing network is necessary. So as per rule, he is entitle for connection after a period of three months from 21-11-2014. An order to give connection to the applicant has already been issued to a contractor M/s. Kulkarni, Wardha, by name. So the application may be dismissed.

After hearing both the parties, the Forum asked Mr.Vaidya within how much time the connection will be given to the applicant? Shri Vaidya stated that the connection will be released within a week, positively. In reply Shri Betal stated that if he gets the connection within a week he is satisfied and he did not want to pursue the matter.

In view of the aforesaid position, we pass the following order,

**ORDER**

- i) The respondent should release the connection within a week positively. Grievance application no.10 of 2015 is disposed of in terms of the above order.
- ii) No order as to cost.
