JUDGEMENT

2. Shri Tilokchand Suganchand Singhvi, presented this application on behalf of Chandra Stone works. According to the applicant his load was not reduced as per his request. So he had suffered a loss

The case was heard on 12-05-2014.

The applicant submitted Xerox copies of the documents in support of his contentions.

The applicant submitted a xerox copy of form A 1. On perusal of the form, it is seen that the original applicant is Mrs. Shantabai Tilokchand Singhvi.

On perusal of the documents, it is noticed that Smt. Shantabai neither authorized Shri Tilokchand Singhvi nor Shri B.V.Betal. Annexure A bears the signature of Shri Tilokchand Suganchand Singhvi. However he is not a person duly authorized by Mrs. Shantabai. Shri Betal appeared before this Forum on the authority given by Shri Tilokchand Suganchand Singhvi. However both these persons are not authorized by the consumer of the MSEDCL.

So in our opinion, it is not legal & proper to proceed in the case.

In view of the above, we pass the following order,

ORDER

- i) The application No.39 of 2014 is hereby dismissed.
- ii) The parties to bear their own cost.
