JUDGEMENT

(Delivered on this 25th day of May, 2015)

2. Shri Rashtrapal M. Tamgadge, At.Po.Yerla, Tq.Hinganghat, Dist.Wardha (hereinafter referred to as, the applicant) had applied to the distribution licensee MSEDCL (hereinafter referred to as, the respondent) for new connection to his agricultural pump set. It is the contention of the applicant that inspite of the fact that he completed all the formalities the respondent had not released the connection within the time limit prescribed under the MERC (standards of performance of distribution licensees, period for giving supply and determination of compensation) Regulations 2014. He approached the IGRC Wardha. The IGRC Wardha dismissed the application

in default vide order passed under no.SE/Wardha/Tech/IGRC/1256 dated 12-03-2015. Feeling aggrieved by the aforesaid order, the applicant presented the instant application under the provisions contained in Regulation 6.4 of the MERC (CGRF and E.O.) Regulations 2006 on 20-04-2015.

3. A copy of the application was given to the respondent. The respondent was directed to submit parawise reply. The respondent submitted reply under no.EE/O&M/H'ghat/Tech/2255 dated 19-05-2015. The case was fixed for personal hearing on 25-05-2015. Shri B.V.Betal, authorized representative was present for the applicant. Shri A.V.Tupkar, Dy. Executive Engineer, Hinganghat (Rural), represented the respondent. Both the parties were heard.

4. It was contended on behalf of the applicant that he submitted an application for connection to his agricultural pump on 29-10-2014. He received demand note on 14-01-2015. He deposited the amount as per demand on 23-01-2015. He submitted the test report on 15-04-2015. In spite of the fact that the application was complete in all respect the respondent failed to release the connection within the stipulated period given in SOP Regulations. So a compensation as provided under Regulation 12.1 may be awarded. Secondly the applicant is entitled for connection under, "Vishesh Ghatak Yojana". So the connection may be released immediately. Furthermore he may be awarded compensation for physical and mental agony.

5. Shri Tupkar, Dy. Executive Engineer, referred to the parawise reply dated 19-05-2015. It was further stated that the applicant submitted the application on 29-10-2014. He was given a demand note. The applicant deposited the amount on 23-01-2015. He

submitted the test report on 15-04-2015. To provide the connection to the applicant a transformer of 63 KVA capacity, HT line admeasuring 0.96 k.m. and L.T. line admeasuring 0.24 k.m. is necessary. As per the SOP Regulations the applicant is entitle for compensation after one year from the date of submission of the test report. So at present his application is premature. Secondly if his name is included in the list of beneficiaries given by the Collector's office, he will be given the connection on priority. At present the application is not entitle for any compensation. The application may be dismissed.

6. We have perused the record. We have heard the arguments advanced by both the parties.

It is admitted position that the applicant submitted an application in the prescribed form. He deposited the amount as per rule. He submitted the test report also.

Regulation 4.9 prescribe the time limit for release of connection, it reads as under,

4.9 “ Where the supply of electricity to a premise requires commissioning of a new sub-station forming a part of the distribution system, the Distribution Licensee shall give supply to such premises within one (1) year from the date of receipt of the complete application and payment of charges. The commissioning of new sub-station forming a part of the distribution system will include sub-station having transformation from HT to HT or HT to LT or switching station from where the HT distribution lines originate.”

After hearing the parties and upon perusal of the record it reveal that the applicant had submitted the complete application on 15-04-2015. To provide the connection to the applicant installation of new substation is necessary. So he is entitle for connection or compensation after 14-04-2016 (i.e. after one year from the date of receipt of complete application). Since as on today the period is not over the applicant is not entitle for compensation and his application for compensation is premature.

The respondent admitted that if the applicant submit a documentary proof that his name is entered in the list of beneficiaries prepared by the Collector, Wardha they will release the connection immediately.

7. In absence of any evidence much less reliable and cogent evidence, we are not inclined to accept other claims of the applicant.

8. In view of the position discussed above we pass the following order,

ORDER

- i) The claim for compensation is hereby dismissed.
- ii) If the applicant produce the documentary evidence that his name is included in the list of beneficiaries prepared by the Collector, Wardha he may be given the connection immediately.
- iii) No order as to cost.
