**JUDGEMENT**

**(Delivered on this 28<sup>th</sup> day of July, 2015)**

2. The applicant is an agriculturist. He submitted an application for electric connection to his agricultural pump set. The applicant stated that he deposited the amount of Rs.4300 towards the security deposit. The amount of Rs.4300 was also deposited by the Government with the respondent for the same connection. The applicant requested that the respondent may be directed to refund the amount with interest.

The applicant approached IGRC Wardha. The IGRC directed the respondent to refund the amount vide order passed on 20-05-2015. The applicant requested that the

amount may be refunded with interest. So he presented this grievance application.

The case was fixed for personal hearing on 27-07-2015. Shri B.V.Betal, authorized representative was present for the applicant. Shri M.S.Vaidya, Executive Engineer, Hinganghat and Shri Prashant Ingale, Assistant Engineer, Hinganghat Rural Sub division represented the respondent.

At the time of hearing Shri Vaidya stated that if the applicant produce original receipt he will refund the amount immediately. If the original receipt is not available the applicant may give written undertaking on a stamp paper. Whenever the applicant produce either the original receipt or the undertaking he will refund the amount without any delay. Shri Betal agreed to approach Shri Vaidya, Executive Engineer in the next week. So we are the opinion that the grievance of the applicant is redressed. The applicant could not establish the circumstances which may entitle him for the interest on the aforesaid amount. So we are not inclined to grant any interest on the amount.

So we pass the following order,

**ORDER**

- i) Application no.49 of 2015 is partly allowed. The applicant may approach the respondent and get his amount.
- ii) No order as to cost.
