## ORDER

( Passed this 20th day of March,2006) ( Per Shri N.J.Ramteke, CHAIRMAN)

In response to the notice for hearing to the parties, Shri Marotrao Kamble, Applicant present in person. Shri V.R.Motghare, Dy.E.E. present for non-applicant. The Forum heard both the parties. All the procedure as per the rule of natural justice has been followed by the Forum. The reasonable and fair opportunity of hearing was given to both the parties.

During the course of hearing, it has come to the notice of the Forum that the arrears of Rs. 12,463/- were outstanding against Dr. Ambedkar High School, Bramhpuri. Shri Kamble informed the Forum that arrears have already been paid to the D.L. on 17.3.2006. Shri Motghare admitted that outstanding arrears received by the D.L.

The issue in the present case is about new connection to Dr. Ambedkar

Boys Hostel at Bramhpuri. The D.L. has already accepted an amount of Rs. 11,000/- as

per demand note. This amount has been paid against new connection on 27/12/2004 by

the Superintendent, Dr. Ambedkar Boys Hostel, Bramhpuri vide receipt No.6981351.

Since the amount of arrears has already been paid by the Head Master of Dr. Ambedkar

School, this issue cannot be mixed up with new connection. The present case pertains to

the new connection. Shri Motghare agreed before the Forum that on receipt of test report

from the Applicant, the new connection would be released within 8 days. Applicant also

agreed that by end of this month, a test report will be submitted to the D.L. Since both

the parties agreed on issue of new connection and all the formalities have been

completed except submission of test report, no issue remains for contention.

In view of above position, the Forum disposes this application with

direction to Applicant to submit test report by end of this month and the non-applicants

shall provide new connection within 8 days from receipt of the test report.
