- 1. The applicant filed present grievance application before this Forum on 21.8.2012 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).
- 2. Applicant's case in brief is that he filed an application for new electrical connection but new connection is

not given to him. The applicant filed several repeated complaints but up till now new connection is not given to him. Therefore the applicant prayed for issuance of directions to M.S.E.D.C.L. to give new connection and to pay compensation of Rs. 5000/-.

- 3. On behalf of non applicant initially preliminary objection is filed Dt. 8.9.2012. It is submitted that the applicant has manipulated and fabricated the document named & styled as "Details of Query No.2" which has been provided to Shri Sunil Jacob under reply of R.T.I. Act and filed before this Forum and attempted to mislead. Document has been manipulated with pen and produced before the Forum. It is submitted that the applicant has not submitted an application for new service connection i.e. A-1 form along with supportive documents of ownership proof, Affidavit, Electrical Contractor Test Report, Photo ID proof. The application may be dismissed.
- 4. Forum heard arguments of both the parties and perused record.
- 5. According to the applicant, he provided all requisite documents along with A-1 form in the office of non applicant. However, according to non applicant requisite documents are not produced by the applicant. The applicant failed to produce any documentary evidence on record to show that the applicant has produced Proof of Ownership, Affidavit,

Test Report of electrical contractor and Photo ID proof in the office of Non applicant. If applicant produces such necessary documents and comply all other formalities, the applicant shall be entitled to get new connection. Hence Forum proceeds to pass following order:-

ORDER

- 1) Grievance application is partly allowed.
- 2) The applicant shall produce Proof of Ownership,
 Affidavit, Test Report of Electrical Contractor, Photo
 ID proof along with A-1 form and shall comply all
 other requisite formalities to get fresh connection.
- 3) On full and final compliance by the applicant, non applicant shall give new electrical connection to the applicant as early as possible.
- 4) Non applicant to comply this order within 30 days from the date of this order.
