ORDER PASSED ON 19.10.2012.

1. The applicant filed present grievance application before this Forum on 21.8.2012 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

2. Applicant's case in brief is that the applicant filed an application for new electrical connection on 17.4.2012 but up till now connection is not given to him. Therefore the

applicant claimed new electrical connection & compensation of Rs. 5000/-.

3. Non applicant denied the applicant's case by filing reply Dt. 5.9.2012. It is submitted that along with A-1 form the applicant did not produce Proof of Ownership, Affidavit, Test Report of electrical contractor and other documents. Therefore non applicant M/s. SPANCO had issued letter No. SNDL/NSC/12-13/23 Dt. 30.5.2012 and informed to the applicant to comply within 7 days failing which application for new connection shall be treated as cancelled. Even then applicant did not produce requisite documents. The application may be dismissed.

4. Forum heard arguments of both the parties and perused record.

5. There is no documentary evidence on record to show that applicant produced Copy of evidence of Ownership, Affidavit, Test Report of Electrical Contractor and other papers. If applicant comply all these formalities by producing necessary documents he is entitled for new connection. Hence Forum proceeds to pass following order :-

ORDER

- 1) Grievance application is partly allowed.
- 2) The applicant shall produce Proof of Ownership, Affidavit, Test Report of Electrical Contractor and

other necessary documents and comply all requisite formalities for obtaining new connection.

- 3) On full and final compliance by the applicant, non applicant shall give new electrical connection to the applicant as early as possible.
- 4) Non applicant to comply this order within 30 days from the date of this order.
