ORDER (Passed on 27.02.2007)

The present grievance application has been filed on 05.02.2007 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance

Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The grievance of the applicant is in respect of non-reduction of the applicant's contract demand of 2850 KVA effective from the billing month of August, 2006. The applicant has also prayed in his grievance application to direct the non-applicant to refund excess amount of demand charges amounting to Rs. 10,35,980/- charged from the month of August, 2006 as per applicable tariff till December, 2006 along with interest etc.

The matter was heard on 27.02.2007.

The applicant's case was presented before us by his nominated representative one Shri R.B. Goenka.

The non-applicant has filed his parawise report before this Forum on 27.02.2007.

The applicant's representative during the course of hearing submitted a written pursis dated 27.02.2007 stating that he wants to withdraw the grievance application since he is seeking clarification from MERC in tariff related matters. He, therefore, requested to allow him to withdraw the present grievance application with liberty to submit fresh application after obtaining clarificatory order from MERC in the matter.

In view of above, the present grievance application stands disposed off as withdrawn.
