## ORDER PASSED ON 08.08.2016.

- 1. The applicant filed present grievance application before this Forum on 23.06.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
- 2. Non applicant, denied applicant's case by filing reply dated 16.07.2016.
- 3. Forum heard arguments of both the sides and perused record.

- 4. Applicant filed application for agricultural connection on 28-05-2015 but demand is received on 31-03-2016. Therefore there is delay in issuing demand for the period 13-06-2015 to 30-03-2016 according to MERC's SOP Regulation.
- 5. According to applicant test report is refused by MSEDCL. There is copy of test report on record filed alongwith application it is dated 12-05-2016. Therefore it is clear by test report was given on 12-05-2016. Infrastructure is not ready therefore MSEDCL to issue connection within 90 days from the date of test report dated 12-05-2016 i.e. on or before 11-08-2016 or within 30 days from the date of application. According to non-applicant there is seniority list but it is not approved by Hon'ble MERC it is not legal and proper.
- 7. Hence forum pass the following order.

## ORDER

- 1. Grievance application is partly allowed.
- Non-applicant is directed to pay compensation for delay in issuing demand for the period 13-06-2015 to 30-03-2016 to the applicant according to MERC's SOP Regulation.
- 3. MSEDCL is directed to issue agricultural connection to the applicant before 11-08-2016 or at least within 30 days from the date of this order.
- 4. Non-applicant to comply within 30 days from the date of this order.
