ORDER PASSED ON 28.5.2015.

1. The applicant filed present grievance application before this Forum on 31.3.2015 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer

Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that his disputed meter is declared faulty in meter testing laboratory but his bills are not appropriately revised. Therefore he approached to I.G.R.C. Being aggrieved by the order passed by I.G.R.C. he approached to this Forum.

3. Non applicant denied applicants by filing reply Dt. 15.4.2015. It is submitted that meter was tested in the laboratory on 28.2.2015 and found faulty. As per order passed by Learned I.G.R.C. bill is already revised. Amount of Rs. 425/- is given credit in March 2015 & Rs. 957/- in April 2015. Grievance application deserves to be dismissed.

4. Forum heard arguments of both the sides and perused the record.

5. We have carefully perused order passed by Learned I.G.R.C. in case No. 241/15 Dt. 27.3.2015. As per this order bill is already revised. Credit of Rs. 425.57 is given in March 2015 & Rs. 957/- in April 2015. Thus total credit of Rs. 1300/- is already given. No much relief can be granted to the applicant considering the facts and circumstances of the case.

6. Order passed by Learned I.G.R.C. is legal and valid and needs no interference. Hence Forum proceeds to pass the following order :-
