- 1. The applicant filed present grievance application before this Forum on 15.07.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
- 2. Non applicant, denied applicant's case by filing reply dated 05.08.2016.
- 3. Forum heard arguments of both the sides and perused record.
- 4. Applicant filed the application for agricultural connection on 08-07-2014 but

demand is issued on 20-11-2014. Therefore there is delay in issuing demand for the period 24-07-2014 to 19-11-2014 and applicant is entitled for compensation according to MERC's SOP Regulation.

- 5. Test report is not given by the applicant. No postal evidence of refusal of test report is produced by the applicant. Therefore we find no force in the contention of the applicant that test report was refused. Applicant did not submit test report and had not completed necessary formalities. Therefore he is not entitled for compensation for delay in releasing the connection.
- 6. Contractor submitted the test report on 01-03-2016 and on receiving the test report, connection was released on 01-03-2016.
- 7. Hence the following order.

ORDER

- 1. Grievance application is partly allowed.
- Non-applicant is directed to pay compensation to the applicant for delay in issuing demand for the period 24-07-2014 to 19-11-2014 according to MERC's SOP Regulation.
- Claim for compensation for delay in releasing connection is hereby rejected.
- Non-applicant is directed to comply within 30 days from the date of this order.
