ORDER PASSED ON 24.6.2015.

1. The applicant filed present grievance application before this Forum on 29.4.2015 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer

Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that her meter is running fast and therefore meter be tested in the laboratory of M.S.E.D.C.L. and to revise the bill. Being aggrieved by the order passed I.G.R.C. applicant approached to this Forum.

3. Non applicant denied applicant's case by filing reply Dated 11.5.2015. It is submitted that Learned I.G.R.C. rejected the grievance application and therefore matter be disposed off.

4. Forum heard the arguments of both the sides and perused the record.

5. As per request of the applicant this Forum passed order Dt. 12.5.2015 during the course of hearing to the effect that meter be tested in the laboratory or M.S.E.D.C.L. and to produce the report.

6. Accordingly meter is tested in the laboratory of M.S.E.D.C.L. Executive Engineer, Testing Division (Urban), MSEDCL, Nagpur produced testing report Dt. 10.6.2015 on record and as per this report meter is O.K.

7. Therefore consumption recorded by the meter is the consumption utilized by the applicant and therefore bill is proper.

8. Order passed by Learned I.G.R.C. is legal and proper and needs no interference. Grievance application deserves to be dismissed.

9. Hence Forum proceeds to pass following order :-
