- 1. The applicant filed present grievance application before this Forum on 25.07.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
- 2. Non applicant, denied applicant's case by filing reply dated 23.08.2016.
- 3. Forum heard arguments of both the sides and perused record.
- 4. Applicant applied for agricultural connection on 04-04-2012 but demand was issued on 30-06-2012. Present application is filed on 25-07-2016 i.e. after

About 4 years. According to Regulation 6.6 of the said Regulation "The Forum

shall not admit any grievance unless it is filed within two (2) years from the

date on which cause of action has arisen". Therefore claim for compensation for

delay in issuing demand is barred by limitation therefore can not be granted.

5. Applicant paid amount of demand on 11-07-2012. But test report is not

submitted. Applicant even can not tell date of test report. Copy of test report is also

not produce on record. Therefore it is clear that test report is not submitted by the

applicant & all necessary formalities are not complied. Therefore supply is not

released.

6. Applicant shall submit the test report & non-applicant shall release the supply

within 90 days from the date of receiving the test report, if the connection is not

released, then applicant shall be at liberty to approach appropriate authority for

compensation, if any.
