The present grievance application has been filed on
12.02.2007 under Regulation 6.4 of the Maharashtra Electricity

Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The grievance of the applicant is in respect of excessive billing for the period from June 2005 to October, 2005.

Before approaching this Forum, the applicant had filed his complaint dated 20.02.2006 addressed to the Executive Engineer, Congressnagar Division, MSEDCL, NUZ, Nagpur on the same subject-matter of the present grievance. It seems that no satisfactory remedy was provided to the applicant's grievance. Hence, the present grievance application.

The intimation given to the Executive Engineer on 20.02.2006 is deemed to be the intimation given to the Internal Grievance Redressal Cell in terms of the said Regulations.

The matter was heard on 09.03.2007

The applicant submitted a written pursis dated 07.03.2007 stating therein that his energy bill for the period from June, 2005 to December, 2005 has been revised to his satisfaction and that now, there is no grievance pending. He, therefore, requested to allow him to withdraw the present grievance application.
