## ORDER PASSED ON 03.10.2016.

- 1. The applicant filed present grievance application before this Forum on 29.08.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
- 2. Non applicant, denied applicant's case by filing reply dated 21.09.2016.
- 3. Forum heard arguments of both the sides and perused record.

- 4. In grievance application applicant claimed to revise the bills of June-2016 & July-2016 on the ground that the bills are excessive.
- 5. In June-2016 consumption is shown 901 unit & in July-2016, 1047 units. We have carefully perused consumption pattern of the applicant. In May-2013 consumption was 1776 unit, in June-2013, 816 unit in June-2014, 821 unit in July-2014, 862 units in May-2015, 709 unit in June-2015, 1398 unit in Oct-2015, 687 unit therefore there is same trend of consumption.
- 6. Spot inspection report shows that there is heavy connected load there are two A/C. Therefore it is but natural to have excessive use.
- 7. As per order dt.21/09/2016 meter was tested in the lab of MSEDCL and as per meter testing report dt.28/09/2016 meter is OK. Therefore consumption utilized by the applicant is correctly recorded by the meter.
- 8. Hence, bill can not be revised therefore we proceed to pass following order.

## ORDER

1. Grievance application is dismissed.
