3. Forum heard arguments of both the sides and perused record.

4. We have carefully perused connected load of the applicant. We have perused order passed by the IGRC. IGRC ordered to revise the total consumption of April-2016 to July-2016 by dividing in 4 months and gave credit towards slab benefit in the ensuing bill of the applicant which comes 236 units p.m. Accordingly bill of the applicant is revised, credit is given & it will effect in the month of September-2016.

5. We have calculated connected load of the applicant and as per calculation consumption of the applicant comes 234 units p.m. Therefore we hold that it is necessary to revise bill of the applicant for the period April-2016 to July-2016 considering monthly consumption of 234 units.

## ORDER

- 1. Grievance application is allowed.
- Order passed by IGRC dated 24-09-2016 in case No.933/2016 is modified and cancelled.
- Non-applicant is directed to revise the bills of the applicant considering 234 units p.m. for the period April-2016 to July-2016 and give credit in the ensuing of the bill of the applicant.
- Non-applicant to submit compliance report within 30 days from the date of this order.
