ORDER PASSED ON 28.10.2015.

1. The applicant filed present grievance application before this Forum on 6.10.2015 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that his bills are excessive. Being aggrieved by the order passed by Learned I.G.R.C. applicant approached to this Forum.

3. Non applicant, i.e. M.S.E.D.C.L. denied applicant's case by filing reply Dated 21.10.2015. It is submitted that meter is tested in meter testing laboratory on 15.9.2015 and it is found O.K. Grievance application deserves to be dismissed.

4. Forum heard arguments of both the sides and perused record.

5. Date of supply is 23.4.2015 recently. Record shows that since the date of supply there is absolutely no payment by the applicant till today for about 7 months and he is enjoying the electricity without any payment.

6. We have carefully perused spot inspection report and connected load. There is sufficient connected load. Considering connected load, consumption shown in CPL is very less. In the month of June 2015 – 158 units, July 2015 – 161 units, August 2015 – 164 units & September 2015 – 135 units. In no month, consumption was excessive. Amount of Rs. 3809.71 is due and outstanding since the date of supply. Spot inspection report also shows that there are two meters in the same premises.

7. Meter is tested in the laboratory and as per meter testing report Dt. 15.9.2015, meter is O.K. Therefore there is no scope for revision of bill. Grievance application deserves to be dismissed. Hence following order :-
