ORDER (Passed on 20.05.2009)

The present grievance application is filed on 01.01.2009 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The grievance of the applicant is in respect of shifting of LT line laid on applicant's house at village Bhisnoor Tahsil Narkhed, Dist. Nagpur. The applicant has requested for shifting of the said line. Hence the present grievance application.

Before approaching this Forum, the applicant had approached the Internal Grievance Redressal Cell on the same subject-matter on 25.08.2008. The applicant had not received any order from IGRC within the time stipulated. The applicant has filed his grievance application on 01.01.2009 to this Forum.

The matter was heard on 06.03.2009.

The applicant contended that the applicant is the consumer of MSEDCL having connection no. DL-00/3 at Mouza Bhisnoor. On dated 30.06.2008 MSEDCL had been shifted LT line from old pole no. I.R. 52 to other pole which resulted that the wires has laid on his house. The applicant has brought this matter to the MSEDCL while shifting of line as said above, and not taken any action of the applicant say. If any accident occurred in future that will be responsibility of the MSEDCL.

The applicant has paid Rs.1000/- on dated 02.02.2009 towards measurement of his land to the office of the तालुका निरिक्षक भुमि अभिलेख नरखेड. Even though survey of his land has not been carried out by the survey department. Again this matter has been informed by the तालुका निरिक्षक भुमि अभिलेख नरखेड to the applicant vide letter no. तालुका निरिक्षक भुमि अभिलेख नरखेड पत्र कं. ९ दिनांक ०४.०३.२००९. If applicant wants early measurement of his land the applicant has to pay Rs.500/- accordingly the applicant has paid of Rs.500/- on dated 05.03.2009 for measurement of his land.(area of house). The applicant has not

received measurement report of land from तालुका निरिक्षक भुमि अभिलेख, नरखेड. Hence, the applicant has not produced requisite documents to the non-applicant.

The applicant has lastly prayed that to shift the line laid on his house and give Rs. 5000/- compensation towards mental harassment.

The non-applicant has submitted his parawise report on dated 16.01.2009 the non-applicant contended that the LT line has laid for supply to street light at village Bhisnoor, the LT line has not laid on the house of Shri Suresh Shankarao Agarkar at Bhisnoor but the applicant has made complaint regarding laying of line on his house and given a complaint for shifting of LT line laid on his house. While joint inspection on dated 13.01.2006 with Sarpanch, Secretary of GramPanchayat of Bhisnoor and non-applicant, it is observed that the said line has laid in middle of road of Gram Panchyat Bhisnoor. The said line is away near about 4 ft. from the house of the applicant and it is laid in the middle of the road of Gram-Panchayat Bhisnoor.

The non-applicant has also contended that Sarpanch Gram-Panchayat Bhisnoor vide letter on dated 26.06.2008, in which it is clearly mentioned that the LT line has laid for street light at village Bhisoor. For safety point of the LT line has been guarded by adequate size of guarding wire. The LT line has not laid on the house of the applicant. It is observed that the construction of the applicant house is not as per the standard rule of construction of Gram-Panchayat vide letter on dated 25.01.2009. But some portion of the house is in the jurisdiction of Sarpanch Gram-Panchyat Bhisnoor (on the road of

Gram-Panchayat). The work of LT line has been constructed as per MSEDCL Rules & Regulations.

We have carefully gone through all the documents produced on record and all submissions, written and oral made before us by both the parties.

The Forum has come to conclusion that the LT line has not laid in the house premises of the applicant.

The applicant's grievance application rejected accordingly in terms of this order.
