1. Present grievance application was filed by applicant as per provisions at CGRF (NRZ) Nagpur and C.G.R.F. Nagpur Rural Zone, Nagpur transferred this matter to this Forum on 13.10.2015 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

- 2. Non applicant, denied applicant's case by filing reply dated 16.10.2015.
- 3. Forum heard arguments of both the parties and perused record.
- 4. Applicant filed application for agricultural connection on 27-06-2014 but demand is given on 19-09-2015 there is delay and applicant is entitle for compensation regarding delay period and issuance of demand according to MERC's SOP Regulations 2005 and 2014.
- 5. Furthermore there is nothing to record to show that applicant paid amount of demand. Receipt of payment of demand note is not produced on record. Therefore it is necessary for the applicant to pay demand and submit test report. Therefore only on fulfillment of requisite compliance non applicant shall issue the connection.
- 6. Record show that ill today test report is not given by the applicant. Copy of the test report is not available with the applicant. Hence the following order.

ORDER

- 1. Grievance application is partly allowed.
- 2. Non applicant shall pay compensation to the applicant and issuing demand note according to MERC's SOP Regulations 2005 and 2014.
- 3. Applicant shall pay amount of demand and shall produce receipt of payment in the office of MSEDCL and produce test report and on such compliance non applicant shall issue agricultural connection in accordance with Rules and Regulations.
- 4. Non applicant is directed to submit compliance report within 30 days from the date of this order.
