3. Forum heard arguments of both the sides and perused record.

4. Record Shows that applicant made part payment of Rs.6000/- on 29-09-2014. On 20-01-2015 applicant issued cheque for Rs.9460/- but it was dishonour. Applicant issued cheque of Rs.8000/- on 30-04-2015 and Rs.10,000/- on 29-05-2015 but these cheques were dishonour. Date of last payment is on 29-09-2014. Since then amount of Rs.49783/- is due and outstanding.

5. As per interim order of this forum dated 26-10-2015 applicant paid Rs.25000/- on 02-11-2015.

Meter is tested in laboratory of SNDL on 06-10-2015 and it is found
O.K.

7. At four times cheques of the applicant are dishonoured. Applicant did not allowed staff of non applicant to take spot inspection. It is not proper.

8. Record shows that since 29-09-2014 applicant is not paying the amount and enjoying electricity free of cost or on credit. It is not proper. Meter is tested and it is found O.K. therefore bills can not be revised. Notice was given to the applicant Under Section 56(1) of Electricity Act and it is legal and proper. Grievance application deserves to be dismissed. Hence the following order.

ORDER

1) Grievance application is dismissed.
