ORDER (Passed on 26.05.2009)

The present grievance application is filed on 06.03.2009 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The grievance of the applicant is in respect of for entitle to get benefit under Krushi Sanjivani scheme. The applicant is requested to obtain benefit under the above said scheme. Hence the present grievance application.

Before approaching this Forum, the applicant had approached the Internal Grievance Redressal Cell on the same subject-matter on 02.01.2007. The applicant had received order from IGRC within the time stipulated. The applicant has not satisfied the order received from IGRC. Hence the applicant has filed the his grievance application on 6.3.2009 The matter was heard on 02.04.2009.

The applicant contended that the applicant is the consumer of MSEDCL having consumer No. 419600266897. The applicant has paid arrears Rs. 5106/- under Krishi Sanjivani Scheme on 24.1.2004, Rs.1865/- on 29.02.2004 and Rs.1862/- on 06.04.2004 against the outstanding arrears at the end of September,2003. However the applicant has not received the benefit under this scheme. As per Circular of MSEDCL after payment of 50% arrears the applicant has entitled to get the benefit under Krishi Sanjivani Scheme. The applicant urged that the arrears at the end of April,2003 out of this the applicant has paid 50% of arrears as said above.

The applicant lastly prayed that to correct the energy bill and give the benefit under Krishini Sanjivani Scheme.

The non-applicant has submitted his parawise report on dated 31.03.2009 the non-applicant contended that

the applicant is not entitled to get benefit under Krishini Sanjivani Scheme as per Comm. Circular No. 691 Dtd. 03.01.2004 and as per Head Office letter No. PR-3/KSY/1242 Dtd. 11.01.2005 the applicant has not paid energy bill for the Month of June,2004 and December,2004 even though 3rd installment has paid by the applicant delayed on 06.04.2004. Hence, the applicant has not benefited under Krishi Sanjivani Scheme.

We have carefully gone through all the documents produced on record and all submissions, written and oral made before us by both the parties.

The Forum has come to conclusion that the applicant has not paid arrears and energy bill as per letter No. 1242 Dtd. 11.01.2005. The applicant has not entitled to get benefit under Krishi Sanjivani Scheme.

Hence, the applicant's grievance application rejected accordingly in terms of this order.
