**ORDER (Passed on 23.05.2007)**

The present grievance application has been filed on 04.05.2007 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The grievance of the applicant is in respect of erroneous arrear amount of Rs.6,884=29 shown as recoverable in his energy bill dated 08.02.2007.

According to him, this arrear amount pertains to the erstwhile builder who had taken the meter for construction purposes in the past and which was subsequently disconnected permanently on 05.04.1997 on account of non-payment of the arrear amount. He has stated that he is not liable to pay this amount.

Before approaching this Forum, the applicant had approached the Internal Grievance Redressal Cell (in short the Cell) by filing his complaint dated 21.03.2007 under the said Regulations. The Cell, upon enquiry and hearing replied the applicant by its letter, being letter no. 2684 dated 23.04.2007 that the applicant is liable to pay this arrear amount. Hence, the present grievance application.

The matter was fixed for hearing on 23.05.2007. On this date, the applicant was did not remain present though noticed. The non-applicant was present.

The applicant has, however, sent a written pursis dated 19.05.2007 stating that his grievance is now redressed by the non-applicant to his satisfaction and he has no complaint to make. He has requested to allow him to withdraw his grievance application.

The non-applicant who was present stated that the applicant's grievance has since been redressed to his satisfaction.

In view of above position, the present grievance application stands disposed off as withdrawn.
