**Interim order (Passed on 01.10.2011)**

It is the grievance application filed by Shri L.S. Jaiswal on dated 16.09.2011 under Regulation 8.3 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (here-in-after referred-to-as the said Regulations.)

The applicant's case in brief is that, one Shri Vishal Vinod Kotawar, plot no. 26, JaiDurga Nagar Society, Pushkar Layout, Somalwada, Nagpur is consumer of MSEDCL

and applicant is tenant of Shri Vishal Vinod Kotwar. The non-applicant alleged that amount of Rs.5658=03 is due and outstanding against the applicant, if this amount is not paid within 15 days, electricity supply of the applicant shall be disconnected. The applicant feel that he has to check his meter because many times, applicant is receiving excess bills.

Therefore applicant filed application for interium relief that his connection should not be disconnected till the dispute is solve.

Forum issued the notice to MSEDCL. Officer of MSEDCL and the applicant were present. Forum heard arguments from both the side and perused the record.

During the course of arguments applicant told that he is ready to deposit amount of arrears of bill under protest by reserving his rights. Officer of MSEDCL argued that if the amount of bill is deposited, there is absolutely no problem. In this way both the parties amicably settled the matter but orally. Later on it was also orally informed by applicant that he deposited amount of arrears of bill. Therefore now no dispute remain between the parties and applicant is fully satisfied hence the Forum proceed to pass the following order.

### ORDER

As the matter is compromise between the parties, therefore the grievance application is disposed of.
