ORDER PASSED ON DT. 18.7.2012.

The applicant filed present Grievance application on Dt. 28.5.2012 under regulation 6.4 of the MERC (CGRF & Electricity Ombudsman) Regulations 2006 (hereinafter referred to as the Regulations).

1. The applicant's case in brief is that on 29.2.2012 inspection team visited his house and asked for arrears payment. The

applicant gave cheque of arrears amount. Suddenly the applicant received a bill Dt. 2.3.2012 under Section 126 of Electricity Act 2003 amounting to Rs. 72,980/- against the theft. Non applicant had changed the tariff from residential to commercial. No commercial activities are going on. There is no theft. Therefore the applicant filed present grievance application and requested to quash the amount of Rs. 72,980/-.

2. Non applicant had filed an application on 29.5.2012 for adjournment, submitting therein that they have to carry out check whether commercial activities are going on or not and whether Section 126 of electricity act is applicable. Till then, M.S.E.D.C.L. will not disconnect supply for payment of arrears of Rs. 72,980/-. Accordingly, the matter was adjourned and time was granted to the non applicant to enquire the correctness of the incidence of theft.
3. On 22.6.2012, both the parties compromised the matter out of Court and filed pursis in writing Dt. 22.6.2012, in which applicant submitted that his entire grievance is fully satisfied and now he has absolutely no grievance.
4. As the matter is compromised between the parties and grievance is satisfied as per Pursis Dt. 22.6.2012, therefore, it is necessary to dispose off the matter. Hence Forum proceeds to pass the following order :-

ORDER

1. Grievance of the applicant is fully satisfied. Therefore grievance application is disposed off.
