ORDER PASSED ON 12.8.2014.

1. The applicant filed present grievance application before this Forum on 16.6.2014 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

2. The applicant's case in brief is that he is receiving excessive bills since April 2014. Accordingly on his complaint meter was replaced and tested in meter testing laboratory on 31.5.2014 and meter was found O.K. Applicant is not satisfied with this result and therefore he approached to I.G.R.C. Learned I.G.R.C. disposed off

grievance application in Case No. 417/14. Being aggrieved by the said order, the applicant approached to this Forum.

3. Non applicant denied applicant's case by filing reply dated 11.7.2014. It is submitted that meter of the applicant was replaced and old meter was tested in meter testing laboratory and it is found O.K. Therefore bill can not be revised.

4. Forum heard arguments of both the sides and perused the record.

5. During the course of hearing on Dt. 15.7.2014, it was ordered by this Forum that meter be tested in the laboratory of M.S.E.D.C.L. and to submit testing report. S.N.D.L. was directed to file spot inspection report and M.R.I.

6. Accordingly, meter of the applicant was tested in the laboratory of M.S.E.D.C.L. Executive Engineer Testing Division (U), M.S.E.D.C.L. Nagpur filed meter testing report Dt. 31.7.2014 on record. As per this report meter of the applicant is found O.K.

7. S.N.D.L. also produced spot inspection report and M.R.I. report on record. There is sufficient load of the applicant. We have carefully perused the CPL and consumption pattern of the applicant.

8. Meter is tested by S.N.D.L. in meter testing laboratory and it is found O.K. Again meter was tested in the laboratory of M.S.E.D.C.L. and it is found O.K. Therefore consumption recorded by the meter is the consumption utilised by the applicant and hence bills can not be revised.

9. We find no substance in the grievance application and it deserves to be dismissed. Hence following order : -

1) Grievance application is dismissed.
