The applicant filed present grievance application before this Forum on 21.6.2012 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

1. The applicant's case in brief is that his meter was sanctioned as commercial, it should fall in the category L.T.-II whereas since beginning the bills are charged in category 02/L.T.-VII temporary others. The applicant is unnecessarily charged at higher rate. Complaints were made every time but Page 1 of 3

only once the bill was reduced manually but thereafter again bills in higher rate were issued. Therefore applicant claimed conversion of billing category from temporary to commercial L.T. II since the date of connection and bills may be revised.

- 2. Non applicant denied the applicant's case by filing reply Dt. 9.7.2012. It is submitted that electrical connection was temporarily given to the applicant for construction purpose and therefore bills in category L.T. VII were issued. The applicant objected for this category and applied for L.T. II Commercial tariff as per application Dt. 28.3.2012 and 25.4.2012. A-1 form of the applicant was perused and tariff was changed into commercial L.T. II. Excess amount recovered from the applicant will be given credit to the applicant in the bill of July 2012.
- 3. Forum heard the arguments of both the sides and perused the record.
- 4. Matter is compromised between the parties outside the Forum and they filed joint pursis of settlement on record Dt. 24.7.2012. As per this pursis, the applicant agreed that he received a statement which is duly corrected and billed as per commercial tariff L.T. II for his meter till June 2012. The applicant is satisfied with the settlement and shall pay the bill received in July 2012 as per settlement along with new tariff plan.

5. Matter is compromised between the parties and grievance application is fully satisfied. Hence Forum proceeds to pass following order:-

ORDER

1) Matter is compromised between the parties and hence grievance application is disposed off.
