ORDER PASSED ON 6.4.2013.

1. The applicant filed present grievance application before this Forum on 8.2.2013 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

2. The applicant's case in brief is that the Applicant applied for N.S.C. on Dt. 26.11.2012 and deposited the amount of demand note of Rs. 1090/-. Consumer No. 410017411130 is allotted to the consumer but up till now electric connection is not provided to the applicant. Applicant approached to Learned I.G.R.C. who decided the matter as per order Dt. 28.1.2013. Being aggrieved by the said order of Learned I.G.R.C. applicant filed present grievance application.

3. Non applicant SPANCO denied the applicant's case by filing reply Dt. 2.3.2013. It is submitted that applicant applied for New Service Connection on Dt. 26.11.2012. The consumer No. 410017411130 was given to the applicant with demand of Rs. 1090/-. The applicant deposited that amount on 3.1.2013. Applicant filed grievance applicant to I.G.R.C. Learned I.G.R.C. directed concerned officers to give fresh connection to the applicant on 28.1.2013. Officers of SPANCO went to the spot to give new connection, but applicant opposed the same. Officers of SPANCO told to the applicant to give some space on the ground floor for installation of the meter but he refused. Finally on 21.2.2013, new connection is already given to the applicant and his grievance is solved.

4. Forum heard the arguments of both the sides and perused the record.

5. During the course of hearing both the parties filed compromise pursis on record to the effect that on 21.2.2013 electrical connection is given to the applicant by installation of the meter and supply is going on. Therefore grievance of the applicant is fully redressed and he is withdrawing his matter.

6. Hence Forum proceeds to pass the following order :-

ORDER

- 1) Matter is compromised between the parties and grievance is fully redressed. Therefore grievance application is disposed off.
