“.....no retrospective recovery of arrears can be allowed on the basis of any abrupt reclassification of a consumer.....Any reclassification must follow a definite process of natural justice and the recovery, if any, would be prospective only as the earlier classification was done with a distinct application of mind by the competent people. The same cannot be categorized as an escaped billing in the strict sense of the term to be recovered retrospectively..... In all those cases, recovery, if any, would be prospective from the date of order or when the matter was raised either by the utility or consumer and not retrospective. ...”

“.....11. In view of order of the MERC referred to above, it is obvious that the respondent could not ask the appellant to pay difference of tariff retrospectively i.e. from May 2008. The respondent can claim difference of tariff only from the date of the inspection by the Flying Squad i.e. from 04/10/2011 and onwards. In view of this position, the provisional assessment bill for tariff difference amounting to Rs. 2,96,409/- as well as the revised assessment for Rs. 1,94,100/- cannot be sustained and they deserve to be quashed. It seems that this aspect was not brought to the notice of the Forum and the Forum erred in dismissing the Grievance of the appellant. Hence, the impugned order of the Forum needs to be quashed. I, therefore, pass the following order.

- (a) *The Representation is partly allowed.*
- (b) *The order of the Forum dated 10.2.2012 is hereby quashed and set aside.*
- (c) *The provisional assessment bill for tariff difference amounting to Rs. 2,96,409/- as well as the revised assessment of Rs. 1,94,100/- are hereby quashed and set aside. ...”*
