1. The Consumer has filed present Grievance application under regulation no. 6.4 of the MERC (CGRF & E.O.) Regulations 2006.
2. Being aggrieved and dissatisfied by the order dated 25th May - 2016 passed by IGRC Pune Rural Circle, Pune, that infrastructure is erected by M/s. Aditya Enterprises, proprietor- Sudam Walke under DDF Scheme as per Circular No. CE (Dist.)/D-III/22197 dated 20.5.2008, if consumer opted for connection as Dedicated Distribution Facility and bear all the expenditure. The line will remain dedicated to the consumer in future. Hence the connection of Mr.Ramdas Walke cannot be connected on infrastructure erected by M/s. Aditya Enterprises without their written consent for same, the consumer

above named prefers this grievance application on the following amongst other grounds.

3. The papers containing the above grievance were sent by the Forum to the Executive Engineer, M.S.E.D.C.L., Mulshi Dn., Pune vide letter no. EE/CGRF/PZ/Notice/18 of 2016/111 dtd.25.05.2016. Accordingly the Distribution Licensee i.e. MSEDCL filed its reply on 05.07.2016.
4. The consumer has applied for new connection for residential purpose (1 phase) at land gat no. 1156 of village Perane. The consumer has paid the necessary amount of firm quotation on 19.10.2015 but he has not received the connection. Thereafter he made application to IGRC, PRC, Pune for getting energy connection immediately. The IGRC decided the grievance of the consumer vide order dated 25.5.2016 referred to above. Consumer filed grievance to CGRF, on 25.5.2016. This office (CGRF, Pune) scheduled final hearing on 13.7.2016. However prior to that the consumer informed this office that energy connection was released in his favour vide consumer no.170711372833 on 11.6.2016 & therefore he does not want to proceed with the matter. It is clear from the say dated 5.7.2016 filed by Ex. Engineer, Mulshi Division that energy connection in the name of Ramdas Sahebrao Walke vide consumer no. 170711372833 was released on 11.6.2016 & meter vide Sr.No.4724011 Make- Rolex has been installed at the premises of the consumer. In view of the said facts & circumstances, the grievance of the consumer does not survive as satisfied.
5. The Technical Member of the Forum (Member/Secretary) was on Earn Leave for medical treatment for the period 14.7.2016 to 26.7.2016 & hence the grievance could not be disposed off within stipulated period.

6. Hence we proceed to pass following order.

ORDER

Grievance of the consumer stands dismissed with no order as to cost.
