- 1) The Consumer has filed present Grievance application under regulation no. 6.4 of the MERC (CGRF & E.O.) Regulations 2006.
- 2) Being aggrieved and dissatisfied by the order dated 30.01.2015 passed by IGRC Pune Rural Circle, Pune, the consumer above named prefers this application on the following amongst other grounds.
- 3) The papers containing the above grievance were sent by the Forum to the Executive Engineer, M.S.E.D.C.L., Rajgurunagar Division, Pune vide letter

no. EE/CGRF/PZ/Notice/06 of 2015/64 dtd.21.02.2015. Accordingly the Distribution Licensee i.e. MSEDCL filed its reply on 16.03.2015.

- 4) Notices for final disposal of this grievance were sent to the consumer & the Ex. Engineer, MSEDCL, Rajgurunagar Dn. Vide Letter No.EE/PZ/CGRF/PZ/Case No.06/2015/131 dtd.24.3.2015. Thereafter the said consumer sent email letter on dtd.26.3.2015 to this forum contending that the SDO Chakan Sub/dn. has issued revised bill of Rs. 54,870/- to him for the month of Jan.2015 giving credit of Rs.35,240/-. He has satisfied due to issuance of the revised bill as above & therefore he paid the said bill vide cheque bearing no. 152462 & 152463 for Rs.30,000/- & Rs.24,870/- respectively drawn on Panjab National Bank, Chakan Branch. Therefore he does not want to proceed with the said grievance. Similarly the Addl. Ex. Engineer, Chakan Sub/dn. in their say dated 26.3.2015 informed to this office that the said consumer has paid the said revised bill & being satisfied is withdrawing the grievance.

This matter was fixed for final hearing on 13.04.2015. On date of hearing the said consumer was absent since he does not want to proceed with the grievance.

Hence we pass the following order.

ORDER

- 1) Grievance of the consumer stands disposed off as withdrawn by him.
- 2) No order as to cost.
