1. Mr.Shanakar Tulshiram Thorat has filed the complaint is X Form before I.G.R.C. on 12.4.2013. The brief facts are as under :
Mr.Thorat stated that, he is owner of property No.72/82, Natawadi. According to him before ten years, on the basis of false documents, electricity supply was given to consumer No.160220219647. He sought information regarding the name and address of the above referred consumer. He requested to verify the position regarding title of the land where meter is installed & take legal steps. He claimed compensation.

The learned I.G.R.C. rejected the claim on the ground that the forum is satisfied that this issue is decided in previous proceeding.

Mr.Thorat filed 'A' form alleging that in 2001 opponent installed meter on false Address. He submitted that the said meter should be verified & the documents regarding title or lease of the land be supplied to him. He prayed that he is regularly seeking the information. Since two years but no such information is supplied to him.

Mr.Thorat relied on application dated 12.4.13. In this complaint Mr.Thorat is consumer vide Con.No.170015822204 having residential connection since 1992. The main prayer of Mr.Thorat is to supply him the documents in respect of M.S.E.D.C.L. meters & title of land.

The documents produced on record show that on 30.4.2013 Dy.Ex. Engineer Ganeshkhind informed to Mr.Thorat the information as per Right of Information Act-2005. The letter addressed by Officer of M.S.E.D.C.L. to Appellate authority. Authority under Right to Information Act 2005 show that requisite information is given to Mr. Thorat.

Mr.Thorat is requesting this forum that the copies be supplied to him. It is his contention that on the basis of false documents electricity supply was given and thus loss is caused even to M.S.E.D.C.L.

Mr.Thorat has requested for the documents regarding M.S.E.D.C.L.electricity connection of 2001. It is pertinent to note that Mr.Thorat himself has produced on record the said documents namely (i) quotation 15.3.2001 ii) Test report dated 16.3.2001 iii) Undertaking dated 13.3.2001 by Prabhakar Jagtap IV. Affidavit dated 13.3.2001 etc.

Mr.Thorat has grievance that supply was given to Mr.Prbhakar Jagtap illegally. It appears that, M.S.E.D.C.L. has permanently disconnected the supply on 20.4.2013.

On the basis of all the documents produced on record, the prayer of Mr. Thorat in clause 4 of Application "A" form does not survive as he himself has produced on record all these required documents.

In the result, we pass the following order –

ORDER

Complaint is disposed of with no order as to cost.
