SUGGESTIONS/COMMENTS ON PETITION FILED BY MSEDCL SEEKING IN-PRINCIPLE APPROVAL OF MOU ROUTE FOR SELECTION OF DISTRIBUTION FRANCHISEE AND BULK SUPPLY TARIFF (BST) FOR THE AREA TO BE DEVELOPED UNDER TOWNSHIP POLICY/SEZ POLICY/INDUSTRIAL POLICY / I.T. POLICY, ETC.

## CASE NO. 62 OF 2009

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) submitted a Petition dated 25.09.2009, under Sections 14 (7), 86 (1) (b), 94 (2) of the Electricity Act, 2003 and Regulation 85 of the MERC (Terms & Conditions of Tariff) Regulations, 2005 seeking Inprinciple Approval of Memorandum of Understanding (MoU) Route for selection of Distribution Franchisee for the area to be developed under Township Policy/SEZ Policy/ Industrial Policy/ I.T. Policy/any planned development, etc.

The Prayers of MSEDCL are as under:

- 1. "Examine the proposals of the Petitioner for a favourable dispensation;
- 2. To approve the MoU route for appointment of distribution franchisee for the area to be developed under Township Policy / SEZ Policy / Industrial Policy / I.T. Policy / any planned development etc;
- 3. To agree and approve or modify on the methodology to determine the Bulk Supply Tariff to be charged for Mixed Loads as well as Industrial Load wherein such Central / State Government Policies are applicable, to the Distribution Franchisee for the power to be supplied at a single input point;
- 4. To approve the Bulk Supply Tariff as determined by MSEDCL as an interim measure till the period the final order is issued for BST to be levied to the Franchisee, by the Hon'ble Commission.
- 5. To determine any commercial terms and conditions for carrying out the Distribution *Franchisee Activities;*
- 6. To provide the direction under which the Distribution Franchisee Agreement needs to be finalised by MSEDCL and Distribution Franchisee;
- 7. Condone any inadvertent omissions / errors / shortcomings and permit MSEDCL to add/change/modify/alter this filing and make further submissions as may be required at a future date;

8. Pass such further and other orders to ensure development of these type of areas, as the Hon'ble Commission may deem fit and proper keeping in view the facts and circumstances of the case;"

Stakeholders can submit their rejoinders on replies provided by MSEDCL either during the public hearing or latest by **Friday**, **April 9**, **2010**.
