1. In Dec. 2015 the consumer No. 065510496382 Shri. Khalid Ahmed Modh. Umar was given abnormal bill of 708952 unit of amount Rs. 3013380/-.
2. The abnormal bill was revised as per actual reading in May 2016 by crediting 693552 unit for Rs. 2738400.94.
3. As per complaint application, the interest from Dec. 2015 to May 2016 amount of Rs. 85034.53 was waived and credited in Jan. 2018 as per I.T. report.

4. On dtd. 28/03/2018 IGRF passed an order for giving detailed analysis of the bill revision report to the consumer. Accordingly on dtd. 05/05/2018 the consumer was informed about corrected bill and requested to pay the bill of Rs. 167340/-.
5. Even after continuous follow up, the consumer not paid the outstanding amount of Rs.167340/- and hence his supply is temporarily disconnected on dtd. 21.06.2018.

It is kindly requested to the Hon. Forum that the abnormal bill of the consumer and interest on Disputed amount is waived and hence disallow the complaint of the consumer. Even after continuous follow up, he did not pay the outstanding amount. Hence due to arrears of the bill, his power supply has been temporarily disconnected. Hence it is prayed to your good self to kindly consider above say judiciously.
