1. As the meter is no display the consumer No. 065518853940 Shri. Shafeeque Ahmed Abdul Rashid Chaudhari was billed on average consumption i.e. of 27040 from the month of June 2016 to Oct. 2016.
2. As per consumer complaint application dtd. 20/02/2018 and spot verification report of AE Navapura Section, the bill of the consumer was revised as per connected load of the consumer mentioned in assessment sheet in Feb. 2018 by giving consumption of 16624 units of Rs. 50184.63/-.

3. The consumer not paid the outstanding amount of Rs. 114340/- and his supply was temporarily disconnected on dtd. 02/03/2018.
4. On dtd 17/05/18 IGRF passed an order for giving detailed analysis of the bill revision report to the consumer. Accordingly the section Incharge had informed to the consumer about his bill revision and requested him to pay the bill.

It is kindly requested to the Hon. Forum that the bill of the consumer was revised as per the connected load as mentioned in the assessment sheet and he was also informed about his revised bill. Even after continuous follow up, he did not pay the outstanding amount. Hence due to arrears of the bill, his power supply has been temporarily disconnected. Hence it is prayed to your good self to kindly consider above say judiciously.
