ORDER PASSED ON 05.10.2018

1. The applicant approached this Forum under regulation 6.4 of the MERC (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations 2006 for redressal of his grievance.
2. It is the contention of the applicant that the Non-applicant failed to issue the electricity bills for agricultural use with consumer

No.410010845363 without taking reading and issued average bills of exorbitant amount.

3. Initially the applicant approached IGRC. However by the order dated 18.06.2018 it was partly allowed with a direction to the Dy.Executive Engineer, MSEDCL, O&M Sub-division No.I, Nagpur to check the premises of the applicant & according to actual spot inspection reported bill may be revised as per rules and regulations of MSEDCL.

4. Non-applicant filed a reply dated 06.09.2018 and submitted that approximate bills were issued for 1854 units per quarter due to meter shown as faulty from June-2016 to June-2018.

5. Today when the matter was called out for final hearing, heard Shri T.B. Ukey, representative of the consumer Shri J.D. Ukey and Shri S.S. Mate, Dy.Exe.Engineer, Hudkeshwar Sub-division..

6. Today the applicant has filed a pursis informing that the Non-applicant has issued the revised final bill of Rs.6000/- for the period from June-16 to June-18 and thereafter it is agreed to issue the bills as per meter reading. The representative of Non-applicant has confirmed this fact .

7. In view of above nothing survives in this grievance application. Hence it stands disposed off as claim settled, however with no order as to costs.
