1. The consumer having meter serial No. 061-10619470 was working Normal and recorded normal consumption of 172 units for period Jan 2016 to Mar 2017, consumption of 2221 unit for period April 16 to March 17 & consumption of 191 unit in April 17, when the meter became faulty and unable to record the Electricity consumed by the consumer. Hence the consumer billed on ZERO Unit from M/O. May 17 to November 17.

2. The consumer meter is replaced on 24/10/2017 and feed online vide application ID no. 11288527 as enclosed herewith. The new meter recorded the monthly consumption of 213 units from the date of replacement till August 18 billing.
3. Considering this hard fact as per the SVR from section office vide letter AE/DJP II/T/009 dtd. 27/01/18 , the average of 183 unit per month for six months i.e. from may 17 to Oct. 17, i.e. 1100 units was applied as assessment units by section office while feeding the replacement report which was quite legitimated average & even below the normal healthy recorded average by the old (monthly average of 221 units ) and new meter (monthly average of 215 units) before & after the disputed ZERO Unit billing span from May 17 to Oct. 17.
4. While applying the average of 1100 units for the span of may 17 to Oct. 17 the billing was executed in only one month i.e. in Dec. 17 which was rectified by given slab benefit vide BR ID No. 7823907 dt. 29/01/2018 & enclosed herewith.

As the electricity bill was correct and legitimated and anticipated by the consumer he has made the payment of it after the required correction of bill vide BR ID No. 7823907 and after verification and cross examination of various documents at city Sdn. Office.

Hence it is our humble request to submersibly reject the application of the consumer for the above facts.
