JUDGEMENT

(Delivered on this 02th day of May 2019)

- **1.** Being aggrieved by the order dated 22-1-2019 by I G R C Chandrapur the applicant approached this forum on 19-3-2019.
- 2. The respondents were called upon to appear and file their submissions. The respondents filed their reply on 30-3-2019.

Applicant

Respondent

 Heard both sides, the applicant relied on SOP Regulations dated 20 May 2014. The Respondent No. 1 also relied upon G.R- Dated 15-11-2018.
For proper appreciation, we would like to give few facts of the case :-

It is the case of applicant that she had filed this application on 19-3-2019 to grant compensation under Regulation 12.2 of M.E.R.C 2014. It is the case of applicant that she had made online application for New electric supply connection in her field situated At Mouza- Warwat. Dist- Chandrapur on 27-6-2018 and 29-9-2018 to respondent No1. Though the period of more then 10 months are over the Respondent No.1 did not take any step to provide electric supply. It is also her case that due to inaction on the part of responder No1. she is suffering great loss so she put her grievance before I.G.R.C. to direct Respondent No.1 to pay compensation as per law. The case of Respondent No.1 is that the Govt. of Maharashtra made policy and started Mukhymantri Saur Krishi Pump Yojna (MSKPY) vide G.R. dated 15/11/2018.

- 4. Upon considering the submissions made by both parties and the GoM. GR dated 15/11/2018. We find the grievance made by the Applicant is without sufficient cause. Admittedly the applicant has made application on 27/06/2018. From the GR dated 15/11/2018 it is clear that GoM. has decided that the demands of supply of electricity made after 31/03/2018 be dealt with this new G.R. The MSEDCL has also issued Circular on dated 24/01/2019 for the implementation of MSKPY. In this Circular it is clearly mentioned that all paid pending applications after 31/03/2018 would be dealt with GR dated 15/11/2018. GR dated 15/11/2018 tied up the hands of Respondent No.1. There is no fault or inaction on the part of Respondent No.1. From the GR dated 15/11/2018 it also appears that the Govt. is very much interested to implement MSKPY for the interest of larger farmers. It also appears that the Govt. has taken care of large number of farmers.
- 5. Having regard to all these facts we proceed to pass the following order :-

<u>ORDER</u>

i) Application is hereby dismissed.
