**ORDER PASSED ON 15.04.2019**

1) The applicant approached this Forum under clause 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations 2006, since aggrieved by the order dated 28.11.2018 passed by Internal Grievance Redressal Cell (IGRC),SNDL, Nagpur,

since his request for grant of new energy connection is rejected both by the Commercial Manager and thereafter by IGRC vide order dated 28.11.2018.

2) The applicant is represented by Shri Sunil Jacob and Shri Sonkusale, Executive Engineer, MSEDCL assisted by Shri Dahasahastra of SNDL appeared for the Non-applicant.

3) Today when the matter is called out the applicant and his representative remained absent. Heard Shri Sonkusale, Executive Engineer, MSEDCL assisted by Shri Dahasahastra of SNDL representative of Non-applicant.

4) The claim is rejected on the ground of failing to produce the sanctioned Building Plan where new electric connection is sought for. During pendency of this proceeding the officials of SNDL visited the site and submitted the photocopy of construction work going on the site of applicant, is still in progress. However, in absence of the Sanctioned Building Plan issued by the competent authority, request cannot be considered. Hence this proceeding is dismissed, however, with liberty to the applicant to apply afresh after getting the Sanctioned Building Plan by Competent Authority and then it be processed in accordance with rules.
