**ORDER PASSED ON 15.04.2019**

1) The applicant approached this Forum under clause 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations 2006, seeking the following reliefs.

1. "MSEDCL authority may please be directed to make the correction in their billing record so that in future all our consumption should be charged with industrial tariff only.
  2. To refund the excess amount wrongly charged from 1<sup>st</sup> September 2010 where from Tariff order under case No.111 of 2009 is effective. Under this tariff it is clarified that consumer categorization should reflect the main purpose of the consumer premises and offices of the industries cannot be levied with commercial tariff.
  3. To refund the excess amount as per Provisions under sub section 6 section 62 of Electricity Act 2003."
- 2) The Non-applicant denied the claim by reply dated 03.04.2019.
  - 3) It appears that the applicant straight way approached this forum without knocking on the doors of IGRC, SNDL, Nagpur.
  - 4) Today when the matter is called on for hearing the applicant and his representative remained absent. Shri Sonkusale, Executive Engineer, MSEDCL on behalf of Non-applicant produced a letter dated 12.04.2019 addressed to the Hon'ble Member Secretary of this forum seeking permission to withdraw this grievance application, on the ground that he already

got the relief from the Non-applicant in December 2018. This application is signed by Director of applicant's Company and it also bears its seal. Its copy is also forwarded to Superintending Engineer, NUC, MSEDCL, Nagpur.

4) The contents of the above referred letter are telephonically confirmed by the Hon'ble Member Secretary during the course of hearing.

4) In view of above, request for withdrawal is accepted and grievance application stands dismissed as withdrawn.
