The applicant approached this Forum under clause 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations 2006, since his claim for compensation for delay in providing new electric connection for 3 HP Agricultural Pump is rejected by IGRC vide order dated 25.01.2019, although a direction is issued to provide electric supply to the applicant as per seniority / waiting list.

- 2) The Non-applicant vide reply dated 30.04.2019 denied the claim for compensation as barred by limitation, although did not dispute the directions granted by IGRC in the matter.
- Today when the matter was called out for final hearing applicant's representative Shri B.V. Betal is present. Non-applicant is represented by Shri H.P. Pawade, Executive Engineer, Hinganghat Division.
- 4) Oral submissions of both the parties heard.
- 5) The applicant claims compensation for delay in grant of electric supply to agricultural pump.
- The Test Report is submitted on 18.10.2016, hence within 3 months, therefrom, supply should have been given i.e. till 18.01.2017. Cause of action to approach IGRC arose within 60 days there from that is till 18.03.2017. However, applicant approached on 27.11.2018.
- 7) As such claim for compensation is barred by limitation, which is rightly observed by IGRC.
- 8) However following order is issued by IGRC in the matter on 25.01.2019.
