# **Recharge:**

#### **Recharge Limit**

- a. First time minimum MahaPowerPay recharge Rs. 5.000/-
- b. Subsequent recharge in multiples of Rs. 1000/-

#### **Recharge payment Option**

Online payment - using Debit card, Credit card, Net Banking.





# **Collection Process:**

- a. After recharge, MahaPowerPay owner can collect the amount from consumers through MahaPowerPay.
- b. Mode of collection from consumer is CASH only.
- c. SMS will be delivered to consumers from MSEDCL on making payment at MahaPowerPay as acknowledgement/receipt of payment. (MahaPowerPay owner can also provide the receipt to consumers from MahaPowerPay Application. Printer details are available on MahaPowerPay portal.)

### d. Sub MahaPowerPay Concept:

The main MahaPowerPay holder/owner agency can assign its MahaPowerPay balance to multiple users by creating sub MahaPowerPay. The transaction and commission related to sub MahaPowerPay users will be accounted in main MahaPowerPay only.



- a. Commission rate is Rs. 5.00 per receipt (Taxes & TDS as applicable).
- b. Commission will be credited in MahaPowerPay on monthly basis.
- c. Online submission of invoice is necessary for crediting the commission.



## Refund of Amount and MahaPowerPay Closure

- a. MahaPowerPay owner can take interim refund from amount in MahaPowerPay through online request.
- b. MahaPowerPay owner can request for closure of MahaPowerPay through online. Head Office, MSEDCL will process MahaPowerPay closure request accordingly.
