J. Opinion of the Forum:

Examining all the records placed before the Forum and the facts brought before it during the hearing, the Forum observes as under

- a. It is very clear that as per Govt letter /notification dated 07 July 2004 and on 26.05.2009 and on 06.06.2014, and on 28-5-2019 wherein existing as well as upcoming industrial establishment in Vidarbha Region are specifically exempted from payment of Electricity Duty till 31-3-2024.
- b. Applicant becomes the consumer of MSEDCL from 24.02.2018, and consumer is connected in Industrial category as per electricity bill issued to him by NA MSEDCL. Hence the benefit of exemption of ED should have been given suo motto to applicant by MSEDCL from first bill.
- c. The Forum noted during hearing before it that the NA accepts the ED refund claim.
- d. The Forum is of the opinion that the NA has to refund the ED from the date of connection as per the GoM notification along with interest.

Opinion of Member Secretary:

As per GoM, Electricity Duty Act 2016, the Electricity Duty matter (or issues) is under the jurisdiction of Govt of Maharashtra. MSEDCL is mediator for the collection of the ED amount (recovered from the consumer) and to deposit the said amount to GoM. Therefore I am of the opinion that Electricity Duty related matter is not within the jurisdiction of the CGRF.

Therefore order by majority is as follows

ORDER

With the above observations, the Forum unanimously passes the following order.

1. The complaint in case no. 09/2019 is partly allowed.

- 2. MSEDCL is directed to exempt ED to the complainant from the next electricity bill and refund the recovered amount on account of ED from the date of connection along with interest at the prevalent bank rate as defined in the MERC Practice Directions of 22 July 2019. It is directed to give credit of this refund along with interest in the next bill to the applicant.
- 3. The parties to bear their own cost.
- 4. MSEDCL is directed to submit compliance report of this order to this office within one month of the order.
