1. PRE-REQUISITES FOR THE POST - OFFICER ON SPECIAL DUTY TO THE CHAIRMAN & MANAGING DIRECTOR (OSD TO CMD):

(i) No. of Post : 1 (One) Open

(ii) Qualification : Bachelor's Degree in Electrical Engineering/

Technology.

(iii) Experience :

- (a) Minimum 15 (Fifteen) years' experience in the Power distribution sector out of which minimum 3 (Three) years experience should be at the level of Superintending Engineer or equivalent.
- (b) Preference will be given to the candidate having the secretarial work experience involving specific job profiles such as providing technical assistance to the top level management, monitoring the policy roll outs, preparation of relevant technical presentations, having good employee management skills and effective leadership qualities with strong customer service orientations etc.
- (c) Preference will be given to the candidates possessing MBA or equivalent degree from a reputed Management School.
- (iv) Upper age limit: 45 years
 - Relaxable by 5 years for the candidates belonging to backward Classes
 - Upper age limit for employees working in MSEDCL is 50 years (Capping age limit)
 - Date of birth as per Secondary School Certificate (SSC) and age as on **09/11/2021** should be mentioned in the application.
- Note (i): The Qualification required for the above mentioned post should be from a University or Institute in India established or incorporated under Central Act or a State Act or any other qualification recognized as equivalent thereto.

- Note(ii): The experience wherever prescribed be considered as the post qualification experience i.e. experience acquired after possessing essential qualification.
- Note(iii): The departmental candidate possessing Degree in Engineering/Technology in any other discipline and who fulfill the condition of required experience shall be considered under direct recruitment provided that they will have to appear for Selection Process and compete along with other candidates.
- Note (iv): Equivalency of outside candidates will be compared/decided on the basis of gross emoluments drawn (other than perks) and job responsibilities.

6. SELECTION PROCESS AND GENERAL CONDITIONS:

- 6.1 Candidates applying for the post advertised shall ensure that they fulfill all eligibility criteria. Their admission to all the stages of the recruitment process will be purely <u>provisional</u> subject to satisfying the prescribed eligibility criteria mentioned in this advertisement. Company will take up verification of eligibility conditions with reference to original documents only after the candidate has qualified the final selection process and prior to issuance of offer/appointment letter.
- 6.2 Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate to be called for interview. The candidates will be short listed commensurate with the number of vacancies.
- 6.3 The details of interview schedule will be communicated to the short listed candidates by e-mail only. No Call letters will be dispatched by post or courier etc.
- 6.4 The list of applicants short listed for selection process will be made available on the website of the Company.
- 6.5 The short listed candidates will have to appear for the Personal Interview at their own cost. Traveling expenses will not be reimbursed.

- 6.6 The candidates will be short listed for selection process based on the educational qualification and experience.
- 6.7 The selection process will consist of Personal Interview by the Competent Selection Committee.
- 6.8 Those candidates who are claiming the benefit of age relaxation under Backward Class category, should produce a Caste Certificate issued by appropriate authority.
- 6.9 The selected candidate shall be posted in the office of the CMD and will be placed in the seniority of Chief Engineer for promotional avenue if any.
- 6.10 The selected candidate will have to serve on the post for minimum 2 years, after which he/she will be liable to post in other office of MSEDCL as per the requirement, in the equivalent capacity of Chief Engineer (Dist.).
- 6.11 This advertisement is published subject to the provisions of Maharashtra Civil Services (declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.
- 6.12 Employees working in Govt./Semi. Govt. Undertaking will have to produce 'No Objection Certificate' from present employer, at the time of interview.
