Respected Sir,

With respect to above subject and in pursuance of Hon'ble Commission Order, it is most respectfully submitted that MSEDCL is facing severe cash-flows issues, which are already placed through various submissions before this Hon'ble Commission. There is never any willingly delayed payment to the wind generators. Instead of financial difficulties MSEDCL, has done payment on best effort basis to the wind generators time to time. The payment done details in last 5 years are tabulated as below:

The important factor for financial crisis of MSEDCL is very low recovery from agriculture consumers although it covers around 30% sale of MSEDCL. In order to recover agriculture consumers arrears herculean efforts are being put up by MSEDCL by introducing Agriculture Policy 2020 and carrying out severe disconnection drive. This has resulted into five times increase in recovery of arrears from agriculture consumers in past 2 years i.e. from 4.6% to 23.5% in FY 2020-21 and 23.9% in FY 202122 upto Feb-2022. This will further increase with the collection in the month of Mar-2022 as MSEDCL is focusing on collection from agriculture consumers and disconnection for recovery of arrears.

Further, the arrears of government departments for supply of electricity to public water works and street light consumer's category are accumulated to the tune of Rs.8960 Crs as on Jan-2022 including interest. The detail of arrears is as below.

For recovery of Govt. Dept. Arrears discussions are going on at various levels of Government. Several meeting has been held with Chief Minister, Dy. Chief Minister and Chief Secretary of GoM. A meeting is also held on 4.03.2022 with Chief Secretary of GoM, for payment of electricity bill arrears of GoM depts., wherein it is assured that they would take up the matter in the cabinet meeting and would pay as per approval of cabinet.

MSEDCL further respectfully submits to the Hon Commission that the company is going through worst financial crisis due to COVID-19 pandemic and subsequent Lock Down imposed by Authorities last year and this year also. During Lockdown period power consumption of subsidising & subsidised consumer i.e consumer mix is totally changed against as approved by Hon'ble Commission and power scheduled is increased drastically for subsidised consumers. Therefore the cross subsidy structure given by the Hon'ble Commission to MSEDCL in the MYT Order has completely collapsed and this has caused loss to the tune of Rs.7500 Crs to MSEDCL.

The financial position of MSEDCL is very precarious and add to that, REC vide its letter dated 07.10.2021 informed that ministry of power has mandated additional prudential norms to REC for

providing future sanctions to State Power utilities wherein for lending working capital loans to Discom the compliance of additional prudential norms of "Working Capital shall be restricted to 25% of total revenue as per audited accounts." is mandated which is very stringent and we may face difficulty for getting working capital loans from REC/PFC and banks in future. Currently, MSEDCL is struggling to comply with few of the norms such as Zero outstanding subsidies from Government, Working Capital Borrowing Restricted to 25% of total revenue, No outstanding dues from Government Department for current period and AT &C Losses and ACS-ARR Gap. The Non-Compliance of any of these norms will lead to ineligibility for future borrowings, Therefore MSEDCL is facing difficulty in raising additional Borrowing. Bank of India vide its mail dated 28th December 2021 has not considered company's loan application on same ground and communicated refusal to sanction the loan. MSEDCL will have to repay the loan amount of Rs.23000 crs up to March-23, which averages to be Rs.1538 crs inclusive of interest per month.

Inspite of all above difficulties MSEDCL, is implementing recovery drives rigorously. However, MSEDCL is finding difficulty in recovery and there is lot of agitations and manhandling to its employees which can be seen from the media news also. MSEDCL has deployed all its staff from Director level to Line staff for recovery of arrears and could recover Rs. 74,963 Cr as compared to Rs. 54,442Cr which is Rs. 20,500 Crs more over the last year even though employees have to face man handling and agitation on field. This may be considered as the highest recovery so far in the history of MSEDCL/MSEB. The comparative figures of recovery is tabulated below:

Thus, MSEDCL is trying at its best for recovery of bills and payment to generators. MSEDCL is bound to comply Hon'ble Commissions order and accordingly MSEDCL had submitted a payment plan on Dated 25.06.2021 to Hon'ble Commission for clearing the principal outstanding dues for generation month Jan 2020 to Dec.2020 amounting to Rs.1973.69 Crs by Dec 2021. In fact of above, MSEDCL has complied and thus cleared all the principal outstanding dues on 28th Dec 2021.

Further, regarding reconciliation of payments, it is most respectfully submitted to Hon. commission that MSEDCL has time to time called the wind generators for reconciliation of data / payments and shared all data, joint verification of this data is done with them and the reconciliation is finalised which is duly signed by generators and MSEDCL. Till date MSEDCL has reconciled the data of around 95 wind generators as per their request and Hon. commission directives which will be continued in future also.

As directed by Hon. Commission, MSEDCL developed a reconciliation mechanism (through NCE portal) by which generators can view invoice wise outstanding and paid amount. Also MSEDCL provides contact details on website/NCE portal. Also, it is submitted to the Hon'ble Commission that generators are already facilitated with the online credit notes as well as billing and payments without any manual intervention.

MSEDCL is taking utmost care for payment of wind generators will be done as per availability of fund. The payment plan for outstanding payments of wind generators is bifurcated as below:

From above table, it is very clear that balance payment from Jan 2021 to Dec 2021 are being done with priority as mentioned above and will adhere to above payment plan on best effort basis as per availability of loan and its financial position.

Further, it is submitted to Hon'ble Commission that it is the continuous endeavor of MSEDCL to abide by the Electricity Act, Rules, Regulations and various orders of the Commission and is always in forefront for the same.

It is submitted to Hon'ble Commission to consider all facts mentioned above sympathetically and consider above reconciliation mechanism and payment plan to wind generators.
