- 3. Scheme Period: Five Months (From 01.01.2025 to 31.05.2025)
- 4. 1st lucky draw, 2nd lucky draw & 3rd lucky draw in Apr 2025, May 2025 & June 2025 respectively will be conducted

Eligibility conditions:

1. Scheme is applicable to MSEDCL's Low Tension (LT) live consumers who have not paid energy bill or paid energy bill using other than online payment mode during last one year prior to 1st Apr 2024 i.e. during 01.04.2023 to 31.03.2024.

- 2. Scheme will not be applicable to Public Water Work & Street light category consumers and consumers under franchisee area.
- 3. Consumer has to make three or more consecutive monthly payments during scheme period by using online payment mode (Net Banking, Debit Card, Credit Card, UPI, Wallet, Cash card, NACH, QR code, NEFT, RTGS etc.)
- 4. At least one energy bill payment using online payment mode in each month, in last three or more months consecutively prior to lucky draw month.
- 5. Minimum payment of Rs. 100/- per transaction.
- 6. Outstanding amount at the last day of month prior to the month, in which lucky draw will be declared, should be Less than Rs. 10/-
