Instructions to the Candidates :-

- 1 It is mandatory for all the examinees to bring in original (2 sets) the "Letter of Cognizance" / "Hall Ticket" along with valid "Identity Card" issued by company while appearing for the examination; without which they will not be permitted to appear for the examination.
- 2 After display of Roll Numbers list, no further Roll Number will be allotted at the Examination Centre.
- 3 Examinees appearing for the examination should make their own arrangement of accommodation.
- 4 Examinees are advised to reach the examination centre sufficiently early & occupy the allotted seat 45 minutes before the commencement of the examination.
- 5 No examinee will be allowed to enter the Exam Hall 30 minutes after the commencement of the examination, except in rare case.
