Sub: Time schedule for giving 3-phase power availability to Ag Load Management (AgLM) Scheme feeders emanating from sub-stations where technical constraints exists for providing day time supply for the month of **September-2026**.

MSEDCL has planned to provide daytime 3-phase power supply to its agricultural consumers through various works like feeder separation, system strengthening, and distributed solar power generation projects under MSKVY 2.0. Accordingly, instructions have already been issued vide Circulars under reference (1) to provide 08 hours of 3-phase power supply to agricultural feeders during daytime where solar feeders have been commissioned under MSKVY.

Further, vide letters under **reference (3) to (5)**, instructions have been issued to provide 8 hours of 3-phase power supply for agriculture feeders during **daytime, wherever it is technically feasible**, duly considering constraints such as transformer loading, line loading, and any EHV limitations, etc. In cases where such constraints exist, the concerned field offices shall be responsible for resolving them under the ongoing schemes. Moreover, it must be ensured that daytime 3-phase power supply to these solarized and technically feasible feeders is strictly limited to **08 hours per day** and must be provided in a suitably staggered time schedule between **07:30 hrs and 18:00 hrs** across all Agricultural (Ag LM) feeders.

Further, in respect of the remaining AgLM feeders, where daytime supply is not feasible due to technical constraints, 3-phase power supply shall be provided for **08 hours either during daytime or night time on a rotational basis**, in accordance with the detailed instructions issued vide **AgLM Circular No. 55 (ref.1)**. Accordingly, the division-wise time schedule for providing 3-phase power availability to such AgLM Scheme feeders has been prepared for the **month of September-2026** and is enclosed herewith as **Annexure-A** for implementation.

The above-mentioned schedule for 3-phase power supply to AgLM Scheme feeders, where exclusive daytime supply is not technically feasible, shall be implemented with effect from **00:00 hrs on 01.09.2026**.

For technically feasible and solarized sub-stations following shall be ensured:

1. For all technically feasible AgLM feeders, 3-phase power supply for 8 hours shall be provided during daytime only, with a suitably staggered schedule between **07:30 hrs and 18:00 hrs** every day.
2. Daytime power supply to all agricultural feeders, where Solar Generation is commissioned under **MSKVY 1.0 or MSKVY 2.0** shall commence from the next day of commissioning of the solar power plant. All such solarized Ag feeders emanating from the same power transformer or substation shall be provided 3-phase power supply for 8 hours during daytime only, with a suitably staggered schedule between **07:30 hrs and 17:30 hrs** every day.

3. As mentioned above, the division wise day time three-phase Ag power supply time schedule shall be prepared and implemented by the concerned field office and the same shall be intimated to this office at the earliest.
4. The Chief Engineer of concerned zone, should ensure that the day time schedule shall be prepared such that in every 15-minute time block the switching ON/OFF of Ag load should not exceed 50 MW. For the cases where it is not possible to execute the same within the time period from 07:30 to 17:30 hours, appropriate proposal may be sent to this office for the approval.
5. The implemented schedule of 3-phase daytime power supply for newly solarized AgLM feeders shall be intimated to this office immediately after implementation.

The above instructions shall be complied with scrupulously.
