RENEWABLE ENERGY CIRCULAR No. 03

Sub: Procedure for levy of Green Power Tariff to the consumers opting for 100% Renewable Energy.

Ref: 1. MERC order dated 22.03.2021 in Case No. 134 of 22.
2. Commercial Circular No. 333 dated 06.05.2021.

In continuation to the Commercial Circular No. 333 dated 06.05.2021, the detail procedure for submission of application by the consumer and for levy of Green Power Tariff to the consumers opting for 100% Renewable Energy is as under:

1. All the applicants (non-Obligated entities) who are interested in availing 100% Green Energy from MSEDCL shall submit the application as per format enclosed as Annexure I.
2. Along-with the application the applicant shall submit the undertaking (enclosed as Annexure II).
3. The tenure for availing the 100% Green Energy shall be fixed as per time period specified by the applicant in its application and no revision will be accepted by MSEDCL for the said period.
4. The applicant shall submit the application to the office of Chief Engineer (Renewable Energy) on email id - greenpowermsedcl@gmail.com
5. The application will be processed and sanctioned by Renewable Energy Section.
6. Once the application is sanctioned the applicant will be informed through return email.
7. The Green Power Tariff of Rs 0.66/kWh, which are over and above the normal tariff of the respective category, will be levied to the consumers opting for 100% green energy.
8. The certificate (Annexure III) regarding 100% Green Energy consumption will be issued along with the month energy bill to the consumer.
9. The Billing & Revenue section will tag the consumer, levy the Green Power Tariff & issue certificate along with the bill to the consumer.

The online portal is being developed for submission of application. Once the portal is ready the details of the same will be informed accordingly.

All the field officers are requested to take note of the above directives and take necessary action accordingly.
