



Composite Billing System for Corporate Users

It is observed that number of Corporate and Government/Semi Government consumers have electricity connections at different locations for their offices across Maharashtra, payment for which are made at respective billing offices of MSEDCL. In many cases the cheques/DD are prepared from a single location i.e. the Head Office/ Regional Office of Corporate user's and sent to the MSEDCL's respective billing offices/collection centers where the connection is located. This results in unnecessary delay in receiving the payment at MSEDCL's end & leading to disconnection and charging of delayed payment charges/interest thereon.

Introduction:

With a view to address these issues of consumers, a mechanism of Composite Billing System has been deployed through which Corporate consumers can pay their electricity bills for all their consumers in MSEDCL's jurisdiction at a single point.

Methodology:

Payment of MSEDCL's energy bill can be done from anywhere by the Corporate consumers using Composite Billing System for Corporate Users portal.

Mechanism:

- Register with Composite Billing system for corporate users of MSEDCL.
- MSEDCL team will verify new users registration details.
- After verification they will approve/reject new users wants use Corporate Billing System.
- On approval of newly registered user, a group is created.
- Against this newly created group the group user can register consumer, view bill, recharge wallet for bill payment etc.
- Enroll required/all the consumer numbers on the portal.
- While registering consumers set bill payment priority (i.e. 1-Prompt Pay Date, 2-Bill Due Date).
- View the electricity bills due of registered consumers.
- Make wallet recharge by RTGS/NEFT/Online Payment.
- Enter the payment details (UTR no., amount, date) in the system.
- Payment details will be verified by MSEDCL team.
- After payment details verification wallet amount will be used for apportion.
- Registered consumers unpaid bills will be apportioned automatically as per above bill payment priority.

Advantages of Composite Billing System to Corporate Consumers:

1. Composite Billing System is designed for the corporate users to create the group and avail multiple facilities like,

- a. Add the consumers which are at multiple location across maharashtra
- b. Make the payment using wallet
- c. Monitor all consumer's paid and unpaid pertaining to their group

2. Able to access all concerned MSEDCL's electricity bills centrally at one portal.

3. As soon as energy bills are generated they are populated on this portal, it helps to make payments within stipulated time & avoid levy of interest, penalty, and delayed payment charges (DPC) & disconnection.

4. Single payment of various locations at a central place.

5. Monitoring consumption pattern of all registered connections.

6. Reduction in time required for passing of bill payment.

7. Consumers can avail Go-Green discount & prompt payment discount.

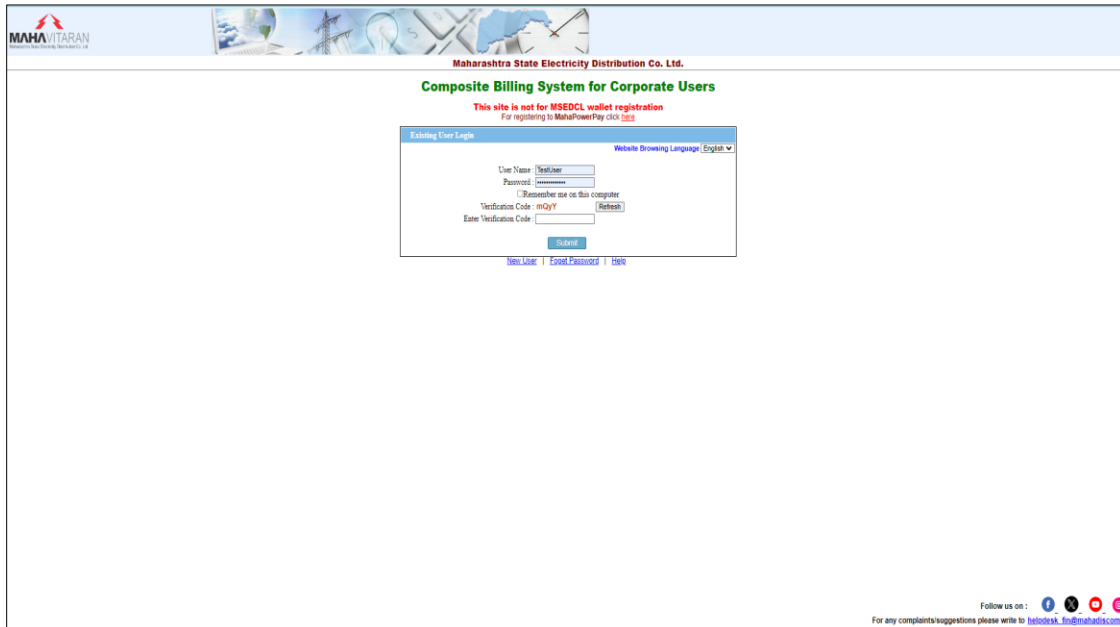
8. It is easy to monitor data online with reference to electricity bills of registered consumers.

9. Various reports are provided for users like Composite Bill Invoice, Paid/Unpaid consumers list, online payment /Bank Transactions report, wallet transaction reports etc.

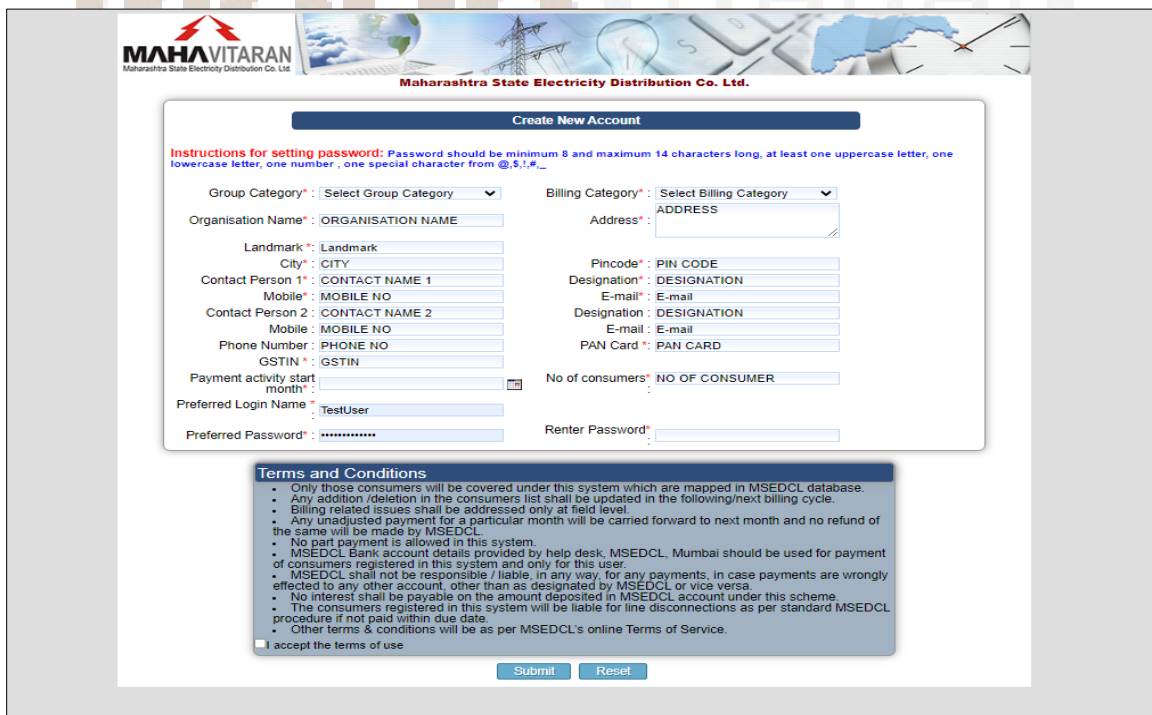
Procedure to register for Composite billing System

Step 1: User Registration:

- Please go to link: <http://compositebilling.mahadiscom.in/UI/login.aspx>
- Consumer has to click on “New User” and fill the required details viz. Group category, Billing category, organization name, address, contact details, PAN, GSTN etc. and preferred login & password.

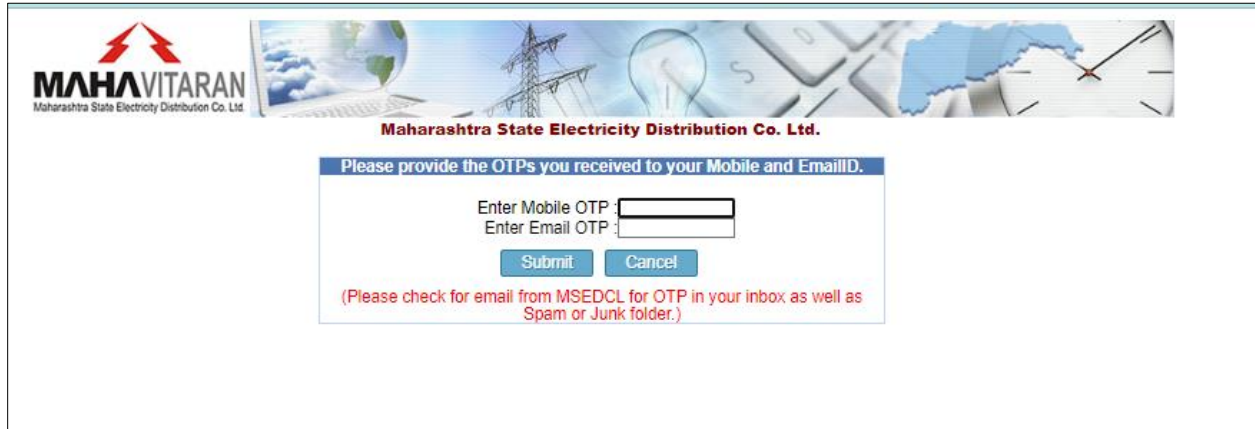

- After successfully completing above steps, MSEDCL team will verify newly registered users details & if found ok they approve the user. On approval a group user will be created and user will be notified by an email.
- This will complete group user registration for composite billing.

Step 2: Registration of Consumers:

- Corporate Consumer identifies all their electricity connections & their respective consumer numbers to be registered.
- Corporate users can register all the identified consumers using single consumer registration at a time or bulk consumer upload facility.
- At the time of consumer registration group users need to set bill payment priority (i.e. 1-Prompt Pay Date, 2-Bill Due Date). Consumers unpaid bills will be selected automatically for apportion & recharged wallet amount will be adjusted against unpaid bills as per bill payment priority.
- For single consumer registration use **CONSUMER CONFIGURATION > Add** menu.

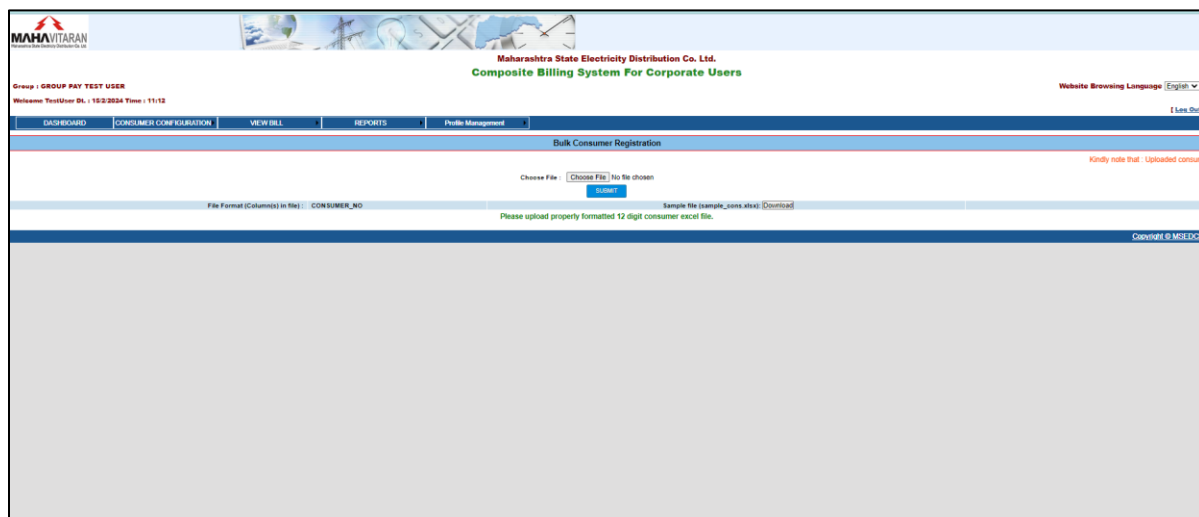
Bulk Consumer Registration:

- Consumer verification & registration

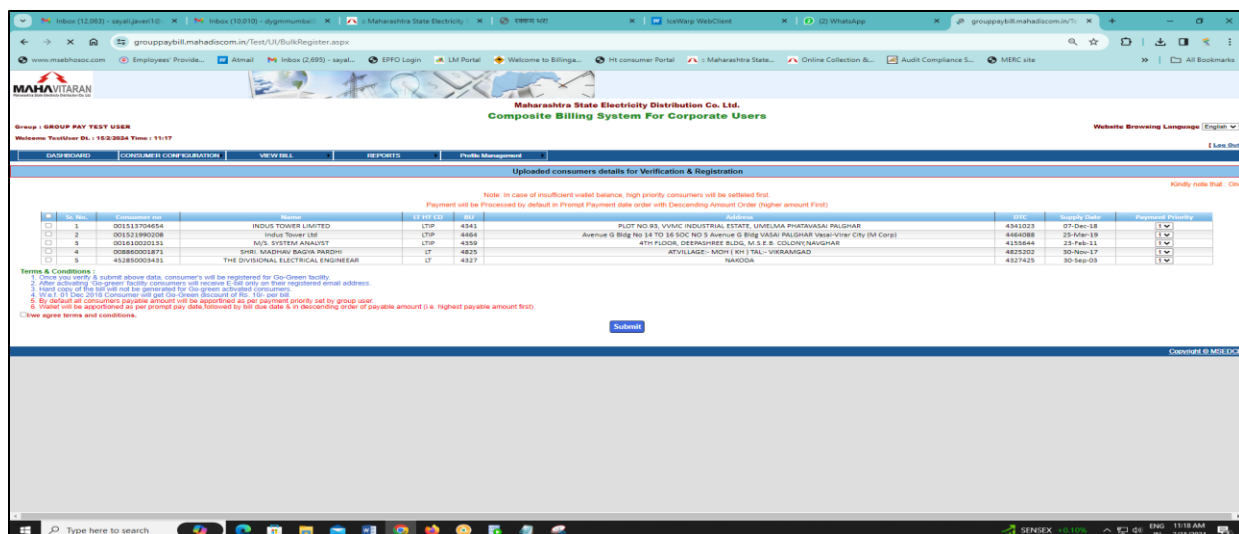
a. Bulk consumers file upload:

- For Bulk Consumer registration click on **CONSUMER CONFIGURATION** menu > **Bulk Consumer Registration** > **Upload Consumer File**.
- Following screen will be displayed, here upload excel file having list of consumer numbers (sample file is also attached for reference).



b. Verify & Register Consumer

- After uploading consumer numbers, group user needs to verify and register consumer. : click on **CONSUMER CONFIGURATION** menu > **Bulk Consumer Registration** > **Verify & Register Consumer**.



- This completes consumer registration process.

Registered Consumer Details

- The registered consumer will appear in the **registered consumer details** under **CONSUMER CONFIGURATION** menu. From this option group user can update Mobile no. PAN, Email, TDS declaration etc.

Wallet Recharge request for LT consumer

To pay LT consumers bills Group users can recharge wallet using facility provided under **CONSUMER CONFIGURATION > Wallet Recharge request (LT)**. Here two options are provided for recharging wallet using online payment or payment via VAN (i.e. RTGS/NEFT). Estimated amount of wallet recharge is shown on top of recharging options. Group users can recharge either with an estimated amount or by entering an amount the user wants to pay.

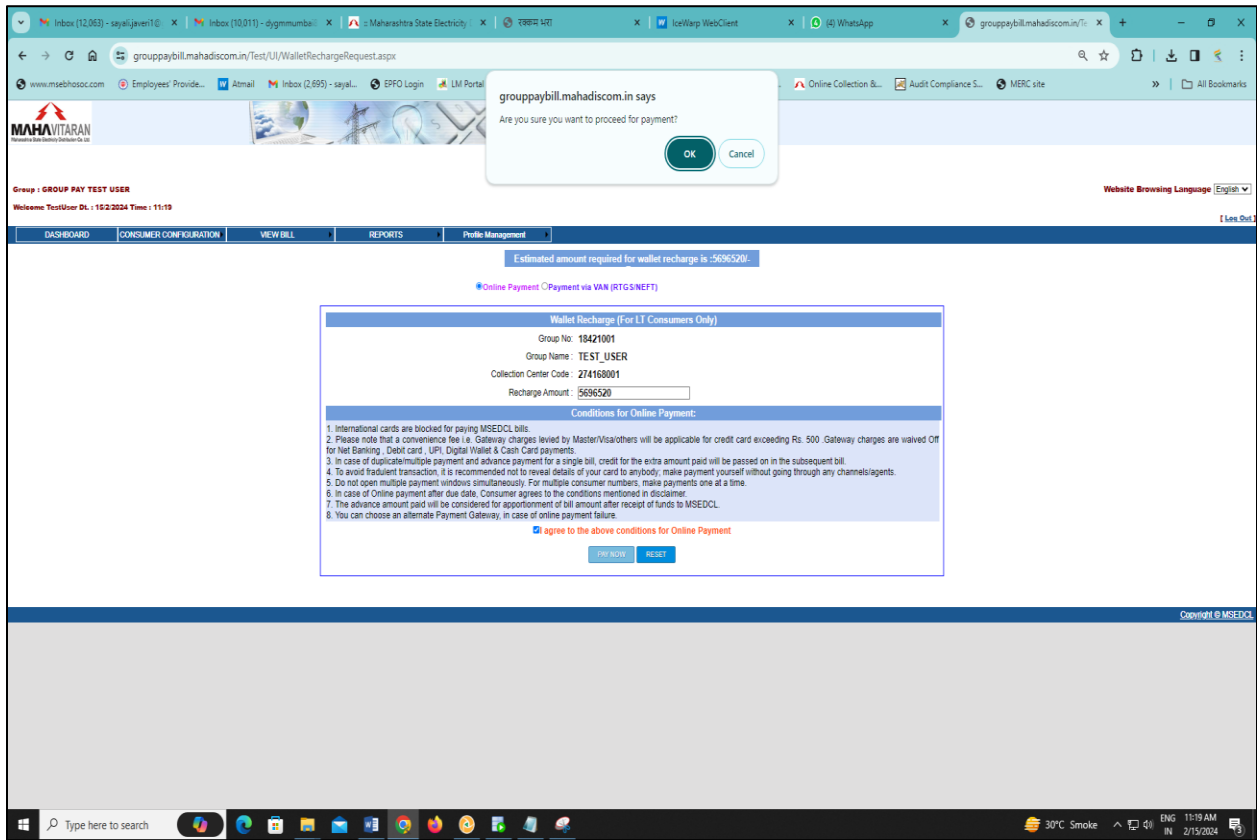

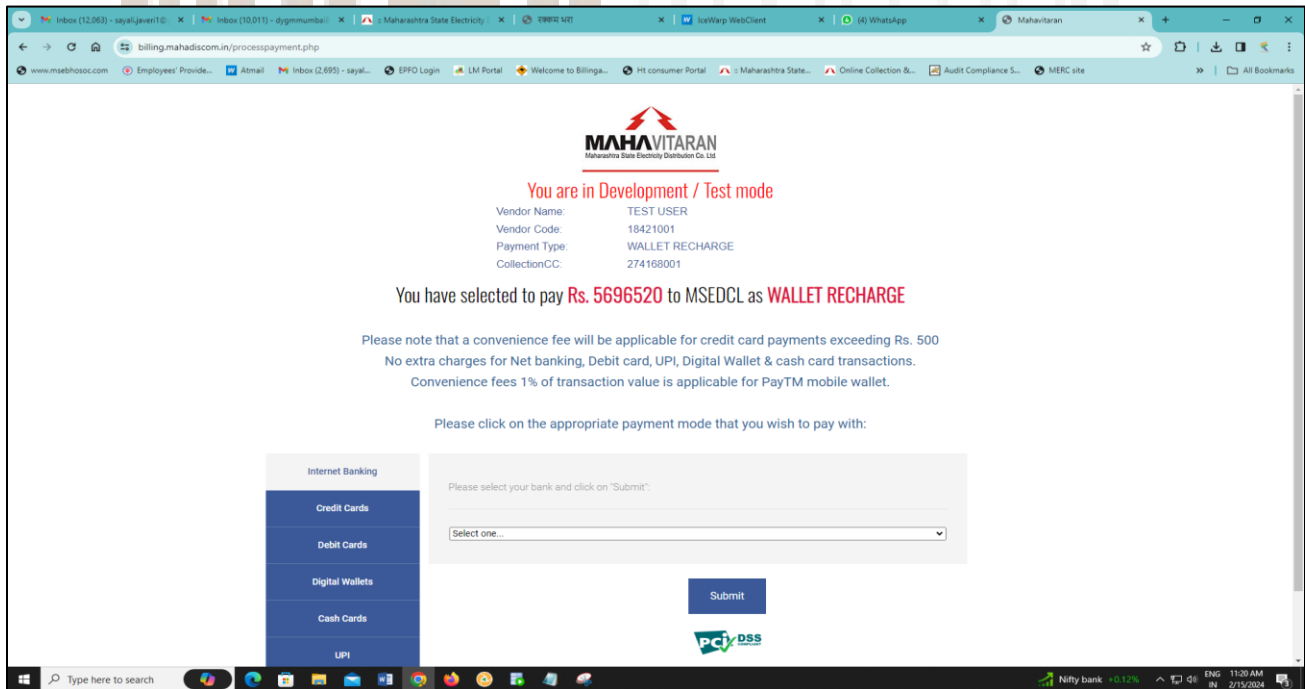

3. In case of duplicate/multiple payment and advance payment for a single bill, credit for the extra amount paid will be passed on in the subsequent bill.
4. To avoid fraudulent transaction, it is recommended not to reveal details of your card to anybody, make payment yourself without going through any channels/agents.
5. Do not open multiple payment windows simultaneously. For multiple consumer numbers, make payments one at a time.
6. In case of Online payment after due date, Consumer agrees to the conditions mentioned in disclaimer.
7. The advance amount paid will be considered for apportionment of bill amount after receipt of funds to MSEDCL.
8. You can choose an alternate Payment Gateway, in case of online payment failure.

Online Bill Payment (HT)

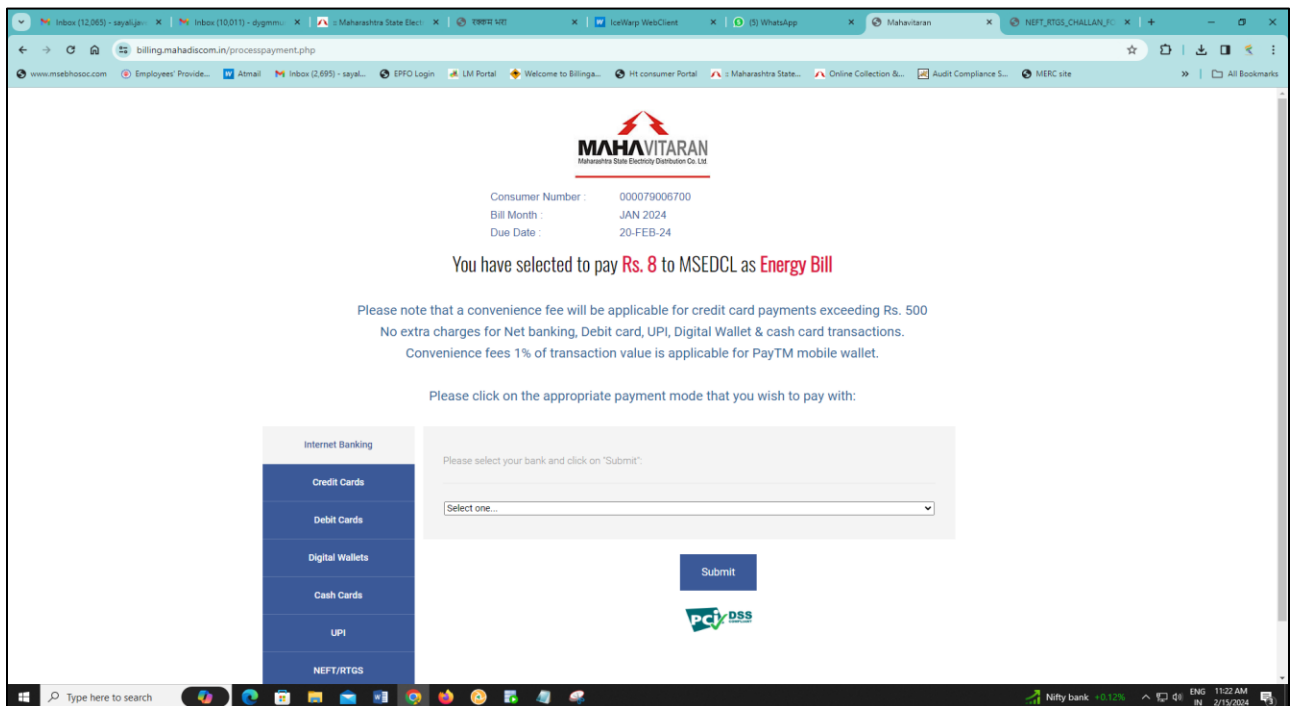
